**CFS Notification No. 08/2019**

Vide Notification No. 02/2017 dated 31.03.2017, M/s. International Cargo Terminal Private Limited has been appointed as "Customs Cargo Service Provider" under the Rule 10 of the "Handling of Cargo in Customs Area Regulations, 2009" for an area admeasuring 66,900 SQM of Container Freight Station ICTPL, located at Village: Koproli Tal: Uran, District: Raigad, Maharashtra- 410 206.

The subject appointment of M/s. International Cargo Terminal Private Limited as Customs Cargo Service Provider for CFS ICTPL was valid for a period of two (02) years w.e.f.31.03.2017.

Vide F. No: S/5-Gen-99/2017-18 CFS M CELL, CFS Notification No. 06/2019 dated 12.06.2019, an additional area of CFS M/s. International Cargo Terminal Private Limited admeasuring 26,070 Sq.Mtrs. was further notified as "Customs Area" under Section 8(a)& 8(b) of the Customs Act, 1962.

Now, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, Utkarsh R Tiwaari, Commissioner of Customs, Nhava Sheva (General), Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House, hereby renew the appointment of M/s. International Cargo Terminal Private Limited as a 'Customs Cargo Services Provider' for the abovementioned Container Freight Station admeasuring approximately 92,970 SQM, subject to the conditions that the Custodian M/s. International Cargo Terminal Private Limited, appointed as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962, the rules under the "Handling of Cargo in Customs Areas Regulations, 2009", and other regulations, notifications, orders issued there under.

2. The Customs Cargo Service Provider shall abide by all the provisions of the Customs Act, 1962 and the Rules under the Handling of Cargo in Customs Area Regulations, 2009, other Regulations, Notifications and orders issued there under.

3. The duration of appointment of M/s. International Cargo Terminal Private Limited as Customs Cargo Service Provider shall initially remain **valid upto 07.06.2023**.

4. The Commissioner of Customs, Nhava Sheva (General), Mumbai Customs, Zone-II, JNCH shall have the Right to review the appointment of M/s. International Cargo Terminal Private Limited as 'Customs Cargo Services Provider', anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009 or as per the directions of the Government of India.
