Vide Notification No. 14/2017 dated 08.11.2017, M/s. Ashte Logistics Private Limited was appointed as appointed as "Customs Cargo Service Provider" under the Rule 10 of the "Handling of Cargo in Customs Area Regulations, 2009" for an area admeasuring 56,631 Square Meters of Container Freight Station M/s. Ashte Logistics Private Limited, located at Village: Ashte, Panvel Rasayani Road, Taluka: Panvel, District: Raigad- 410 206.

The subject appointment of M/s. Ashte Logistics Private Limited as Customs Cargo Service Provider for the CFS M/s. Ashte Logistics Private Limited was valid till 19.11.2019.

Now, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, Utkaarsh R Tiwaari, Commissioner of Customs, Nhava Sheva (General), Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House, hereby renew the appointment of M/s. Ashte Logistics Private Limited as a 'Customs Cargo Services Provider' for the abovementioned Container Freight Station admeasuring approximately 56,631 Square Meters, subject to the conditions that the Custodian M/s. Ashte Logistics Private Limited, appointed as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962, the rules under the "Handling of Cargo in Customs Areas Regulations, 2009", and other regulations, notifications, orders issued there under.

2. The Customs Cargo Service Provider shall abide by all the provisions of the Customs Act, 1962 and the Rules under the Handling of Cargo in Customs Area Regulations, 2009, other Regulations, Notifications and orders issued there under.

3. The duration of appointment of M/s. Ashte Logistics Private Limited as Customs Cargo Service Provider shall remain **valid upto 22.05.2023**.

4. The Commissioner of Customs, Nhava Sheva (General), Mumbai Customs, Zone-II, JNCH shall have the Right to review the appointment of M/s. Ashte Logistics Private Limited as 'Customs Cargo Services Provider', anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009 or as per the directions of the Government of India.
