**CFS Notification No. 03/2019**

The area admeasuring 60,650 SQM of Container Freight Station located at Village-Veshvi, Taluka-Uran, District - Raigad, Maharashtra of M/s T.G. Terminals Private Limited was declared as "Customs Cargo Service Provider" under the Rule 10 of the "Handling of Cargo in Customs Area Regulations, 2009" vide Notification No. 05/2016 dated 01.09.2016.

Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, Utkarsh R. Tiwaari, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva, hereby approve M/s T.G. Terminals Private Limited as a 'Customs Cargo Services Provider' for the abovementioned Container Freight Station of M/s T.G. Terminals Private Limited, subject to following conditions:

1. The Custodian M/s T.G. Terminals Private Limited approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the "Handling of Cargo in Customs Areas Regulations 2009", other regulations, notifications, orders issued there under.
2. The duration of the appointment of M/s T.G. Terminals Private Limited as 'Custodian' and as the 'Customs Cargo Services Provider' shall remain for Ten (10) years from the date of issue of this notification.
3. The Commissioner of Customs (General) shall have the Right to review the approval as 'Customs Cargo Services Provider' anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009" or as per the directions of the Government of India.
