**Notification No. 01/2019**

In exercise of the powers conferred upon me under Section 8(a) of the Customs Act, 1962, I, Utkaarsh R Tiwaari, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava-Sheva, hereby notify areas as specified in Para 2 below, of this notification, in respect of M/s Karanja Terminal & Logistics Pvt. Ltd. located at Karanja Creek, Village Chanje, Taluka Uran, District Raigad, Maharashtra, as places for the purpose of unloading imported goods and loading of export goods or any class of such goods.

2. Further, I, Utkaarsh R Tiwaari, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava-Sheva, in exercise of the powers conferred upon me under Section 8(b) of the Customs Act, 1962 hereby specify the limits of the Main Berth having area of 5000 sq.m (length 200 m & width 25 m) and the limits of terminal area of 93906 sq. mtrs which includes Bulk Wharf of length 200m, Multi Cargo Customs bonded area of 13855 sq.mtrs and Bulk Yard Customs bonded area of 9884 sq.mtrs having coordinates as mentioned below, in respect of M/s Karanja Terminal & Logistics Pvt. Ltd. located at Karanja Creek, Village Chanje, Taluka Uran, District Raigad, Maharashtra.
