Vide Notification No. 12/2016 dated 23.12.2016, Container Freight Station M/s. International Cargo Terminal Private Limited located at Village: Koproli Tal: Uran, Distt: Raigad, Maharashtra- 410 206 had been notified as "Customs Area" for an area admeasuring 66,900 SQM.

M/s. International Cargo Terminal Private Limited vide its application dated 15.05.2019 had further requested for the expansion of its Yard (Phase-2) for an additional / proposed area admeasuring 26,070 Sq.Mtr which is adjoining the existing premises of CFS M/s International Cargo Terminal Private Limited.

Now, in the exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, Utkarsh R Tiwaari, Commissioner of Customs, Nhava Sheva-General, Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House, hereby notify Container Freight Station situated at Village/Post: Koproli, Taluka-Uran, District:Raigad, Maharashtra-410 206 of M/s. International Cargo Terminal Private Limited as a place for unloading of imported goods and for loading of export goods, subject to the strict observance of the Provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs, Nhava Sheva-General, Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House from time to time.
