Attention of all Exporters, Customs Brokers, Customs Cargo Service Providers (CCSRs/ CFS) and Public is invited to the [Boards Circular No. 22/2012](#) dated 07.08.2012 and [Public Notice No. 50/2012](#) dated 24.08.2012 issued by Commissioner of Customs (Export) Nhava Sheva.

3.To further facilitate the exporters it has been decided to extend the 24×7 facility w.e.f. 5th January, 2015 to the below mentioned categories of exports also:

i)Exports of perishable goods (fruits, meats tamarind products etc.) under Duty Drawback Scheme where no pre-requirement from Regulatory Authorities is prescribed; and,

ii)RMS facilitated Drawback Shipping Bills where no examination order or no pre-requirement from Regulatory Authorities is prescribed.

4.The officers posted in the second shift between 10 P.M. to 10 A.M. will be available at following CFS (mentioned in column No. 3 of table below) to cater to the clearances in the cluster of CFSs mentioned against them in column No. 4 below:
