PUBLIC NOTICE NO. 84 /2020

M/s. Central warehousing Corporation, (i.e. CWC) located at D' Node, Taluka Uran, Distt. Raigad, Maharashtra was earlier declared as Custodian of Container Freight Station under section 45 of the Customs Act, 1962 vide notification no. 24/2006 dated 01.08.2006 and the approval has been renewed from time to time vide various notifications issued in this regard. Vide Notification No. 20/2015 dated 17.04.2015, the renewal of approval as CCSP and Custodian has been extended for further 5 years was valid till 15.03.2020.

2. Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, Sanjay Mahendru, Commissioner of Customs, NS-General, JNCH, hereby renew the appointment of M/s. Central warehousing Corporation, D' Node as 'Custodian' of the imported goods received at the Container Freight Station M/s. Central warehousing Corporation, D' Node until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provision of Chapter VIII of the Customs Act, 1962. Similarly, M/s. Central warehousing Corporation, D' Node will also be the 'Custodian' of the Export Cargo brought into said Container Freight Station, for examination and stuffing till their exportation through Jawaharlal Nehru Port.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the 'Handling of Cargo in Customs Areas Regulations 2009', I, Sanjay Mahendru, Commissioner of Customs, NS-General, JNCH, hereby renew the approval of M/s. Central warehousing Corporation, D' Node as 'Customs Cargo Services Provider' and 'Custodian' for the said CFS M/s. Central warehousing Corporation, D' Node subject to the following conditions;

(i) M/s. Central warehousing Corporation, D'Node approved as 'Customs Cargo Services Provider' and 'Custodian' for the said CFS shall abide by all the provisions of the Customs Act, 1962, the rules of the 'Handling of Cargo in Customs Areas Regulations, 2009' and other regulations, notifications, orders issued there-under.

(ii) The duration of appointment of M/s. Central warehousing Corporation, D' Node as 'Custodian' and as 'Customs Cargo Services Provider' shall remain valid for five (5) years from 15.03.2020.

(iii) The Commissioner of Customs, NS-General, JNCH, shall have right to review the approval as 'Customs Cargo Services Provider' and 'Custodian' before completion of five years for their failure to comply with any of Regulations of the 'Handling of Cargo in Customs Areas Regulations, 2009' by CWC D'Node or as per the directions of the Government of India.
