CFS M/s Take Care Logistics Park (India) Private Limited located at Palaspe, Panvel-Goa Highway, Tal Panvel, Dist-Raigad-410206 was appointed as Custodian under Section 45 of the Customs Act, 1962 vide Notification No. 30/2015 dated 14.07.2015. The area was declared as Customs Area under Section 8 of Customs Act, 1962 vide Notification No. 29/2015 dated 14.07.2015. Further, M/s Take Care Logistics Park (India) Private Limited has been appointed as Custodian and Customs Cargo Service Provider for five (05) years vide Notification No. 08/2017 dated 08.06.2017 in respect of its Notified area of 36,456 SQM which was later extended vide Public Notice No. 27/2022 dated 06.06.2022 up to 20.09.2028. And, whereas name change from M/s Take Care Logistics Park (India) Pvt. Ltd. to M/s Hind Terminal Pvt. Ltd. was approved vide Notification No. 70/2023 dated 14.08.2023.

And whereas, M/s Hind Terminals Private Limited had applied for shifting/ change of CFS from their existing location at Palaspe, Panvel-Goa Highway, Tal Panvel, Dist-Raigad-410206 to new location at Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra-410206.

And whereas, consequent upon issuance of Public Notice No. 12/2026 dated 20.01.2026, an area admeasuring 87,832 square meters at new location, Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra-410206 was notified as a customs area for CFS operations.

Further, vide Public Notice 13/2026 dated 20.01.2026 CFS M/s. Hind Terminals Private Limited appointed as Custodian of the imported goods received at their CFS situated at Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra-410206.

Whereas, upon completion of the shifting of activities from the old location at Palaspe, Panvel-Goa Highway, Tal. Panvel, Dist. Raigad - 410206 to the new location at Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra - 410206, and commencement of operations

thereat, the Customs Area at the old premises has become non-operational and unusable for CFS activities.

Now, therefore, in exercise of the powers conferred under Section 8(a) of the Customs Act, 1962, I, Unmesh Sharad Wagh, Commissioner of Customs (General), JNCH, Nhava Sheva, hereby denotify the Customs Area admeasuring 36,456 square meters of CFS M/s Hind Terminal Pvt. Ltd., situated at Palaspe, Panvel-Goa Highway, Tal. Panvel, Dist. Raigad – 410206, earlier notified vide Public Notice No. 29/2015 dated 14.07.2015.
