Sub: Synchronisation of data-base of an exporter operating under Drawback **Scheme.**

It has been brought to the notice of the undersigned that in some cases the details of an exporter, operating under drawback scheme, given in the Bank, while opening an account, do not match with the details furnished to the Customs Department. The following types of data mismatch have been noticed.

- a) Mismatch of IEC number.
- b) Mismatch of Name of the Exporter
- c) An exporter may be having an account in the bank but no record is available with Customs Department and vice-versa.
- d) An exporter may be having more than one account against one ICE number.
- e) Other cases.

Branch and Customs Department are requested to approach SBI, NSPP Branch for correction or before 30-04-2004. For confirmation rectification on or of details they approach Shri S. Mohanthy, Supdt. of Customs, Drawback Section, Hall No.403, C-Wing. The STA/TAincharge of Bank Account Number as NULL for ther Exporters/IECs whose data is mismatching with the database of Bank and Customs on 01-05-2004. After -01-05-2004, the accounts of the Exporters whose details do not match with the database of the SBI, NSPP Branch and the Customs Department will be made inoperative. On 01-05-2004, the EDI system will automatically update the account number in Shipping Bill for which it has been made null for all the shipping bills for that particular exporter and no drawback amount can then be transmitted to the bank by the banks scroll. However, on rectification/ correction of the database leading to registering the valid account number all the Shipping Bills pertaining to that exporter will be updated with a new account

3. Attention of staff working in drawback Section of this Custom House is further invited to the following procedure for opening a new bank account for the purpose of getting drawback remittance.

i. For opening a new account with the bank for the purpose of drawback remittance, the exporter shall approach STA/TA in EDI Core Group on 2nd floor, C-Wing of JNCH with a written request in the prescribed format.

Request for opening of an account in the bank for drawback purpose.

- ii. The STA/TA in EDI Core Group will register the application and forward the same to the bank under dated signature.
- iii. The exporter will then approach the Bank Manager with relevant documents for opening an account for the purpose of drawback.
- iv. The bank will open an account in the name of the exporter for drawback purpose only if the above format duly signed and registered by the Customs Department is presented to the bank.

This new procedure of opening bank account will come into effect from 03-05-2004.
