withdrawal of import permit for importing agricultural commodities
listed in Schedule VII of the Order reg.

being vide Notification S.O. 1322(E) dated 18.11.2003 stipulates that no consignment of Plant or Plant products or other regulated article shall be imported into India without a valid permit issued under this order. Further, as per clause 3(22) ibid no article packed with packaging materials shall be released by the proper officer of Customs unless the consignment is accompanied by a phytosanitary certificate in respect of said packaging material.

the amendment in Clause 3(1) after the word consignment, the word other than those listed in Schedule VII has been added. Hence the requirement of import permit for importing the agricultural commodities listed in Schedule VII of the said Order has been withdrawn. However, the Plant Quarantine inspection / treatments are mandatory for the agricultural commodities listed in the said Schedule.
