NOTIFICATION NO. 01 / 2016

1. The area measuring approx. 76654 SQM of Container Freight Station of M/s. JWR Logistics Pvt. Ltd. located at Village-Padeghar, Tal: Panvel, District:Raigad, Maharashtra – 410 206 was declared as a 'Customs Area' under Section 8 of the Customs Act, 1962 vide Notification No. 22/2013 dated 26.08.2013 and M/s. JWR Logistics Pvt. Ltd. was appointed as a Custodian for that area under Section 45 of the Customs Act, 1962 vide Notification No. 01/2014 dated 04.02.2014 issued from F. No. S/5-Gen-02/2012 CFS M Cell JNCH, of this Customs House. Further, under the provisions of Regulation 10 of the "Handling of Cargo in Customs Areas Regulations, 2009" M/s. JWR Logistic Pvt. Ltd. was approved as a "Customs Cargo Service Provider" for the said CFS for a period of two years vide aforementioned Notification No. 01/2014 dated 04.02.2014.

2. Under Regulation 8 of HCCAR, 2009; M/s. JWR Logistics Pvt. Ltd. was permitted to commence the operations as a Customs Cargo Service Provider for Custody of imported and export goods for handling of such goods in the area notified under Notification No. 22/2013 & 01/ 2014 dated 26.08.2013 and 04.02.2014 respectively with effect from 06.03.2014 vide Commissioner of Customs (Exp.) order dated 28.02.2014 in F.No. S/5-Gen-02/2012 CFS M. Cell.

3. An additional area of approx. 37235 Sq. Mtr. was notified as a 'Customs Area' under Section 8 of the Customs Act, 1962 vide Notification No. 28/2015 dated 07.07.2015. Thus, the total CFS area notified under Sec. 8 of the Customs Act 1962 is 113889 Sq. Mtr.

4. CFS M/s. JWR Logistics Pvt. Ltd. vide letter No. Nil dated 10.09.2015 had earlier applied to appoint them as a Custodian and CCSP for the additional area of 37235 SQM that was notified as a Customs Area vide aforementioned Notification No. 28/2015 dated 07.07.2015.

5. Now, in exercise of the powers conferred on me under Section 45 (1) and 141 (2) of the Customs Act, 1962, I, as Principal Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. JWR Logistics Pvt. Ltd. to be the 'Custodian' of the Imported goods received at the Container Freight Station of M/s. JWR Logistics Pvt. Ltd. until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962 for the entire Customs Area of 113889.00 Sq. Mtr. Similarly, M/s. JWR Logistics Pvt. Ltd. will also be the 'Custodian' of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

6. Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Area Regulations, 2009”, I, as Principal Commissioner of Customs (General) hereby approve M/s. JWR Logistics Pvt. Ltd. as a “Customs Cargo Service Provider” for the entire Customs Area of 113889 Sq. Mtr. of the CFS M/s. JWR Logistics Pvt. Ltd. **subject to following conditions:**

(i) The Custodian M/s. JWR Logistics Pvt. Ltd. approved as Customs Cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the Rules of the “Handling of Cargo in Customs Areas Regulations, 2009”, other Regulations, Notifications, Orders issued there under.

(ii) The duration of the appointment of M/s. JWR Logistics Pvt. Ltd. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain valid for five (5) years from 04.02.2016, unless otherwise suspended / revoked /cancelled prior to the expiry of the said period.

(iii) The Commissioner of Customs (General) shall have the right to review the appointment of M/s. JWR Logistics Pvt. Ltd. as ‘Custodian’ and/ or as “Customs Cargo Service Provider” before the completion of five years for failure to comply with the provisions of the Customs Act, 1962 in general and / or of “Handling of Cargo in Customs Areas Regulations, 2009” in particular.
