CFS NOTIFICATION NO. 02/2017

The area admeasuring 66,900 SQM of Container Freight Station (CFS) located at Village-Koprol, Tal-Uran, Distt. -Raigad., Maharashtra, of M/s International Cargo Terminal Pvt Ltd was declared as a 'Customs Area' under Section 8 of The Customs Act, 1962 vide Notification No. 12/2016 dated 23.12.2016 falling under the jurisdiction of Commissioner of Customs (NS-I) of Jawaharlal Nehru Customs House.

2. Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby appoint M/s International Cargo Terminal Pvt Ltd to be the Custodian of the imported goods received at their Container Freight Station admeasuring approx. 66,900 SQM until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act, 1962. Similarly, M/s International Cargo Terminal Pvt Ltd will also be the Custodian of the Export Cargo brought into said Container Freight Station, for examination and stuffing till their exportation through Jawaharlal Nehru Port.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, Subhash Agrawal, Commissioner of Customs (General), JNCH hereby approve M/s International Cargo Terminal Pvt Ltd as a 'Customs Cargo Services Provider' for the abovementioned Container Freight Station of M/s International Cargo Terminal Pvt Ltd, subject to following conditions:

(i) The Custodian M/s International Cargo Terminal Pvt Ltd approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962, "Handling of Cargo in Customs Areas Regulations 2009", other regulations, Notifications, orders issued under Customs Act, 1962 and/or any other law for the time being in force.

(ii) The duration of the appointment of M/s International Cargo Terminal Pvt Ltd. as ‘Custodian’ and as the ‘Customs Cargo Services Provider’ shall remain for Two (02) years from the date of issue of this notification.

4. The Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Services Provider’ anytime for failure to comply with any of the Regulations of the “Handling of Cargo in Customs Areas Regulations 2009 or as per the directions of the Government of India or provisions of the Customs Act, 1962.
