CUSTOMS NOTIFICATION NO. 05/2017

In exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava Sheva, hereby notify the Parking Plaza/Holding Area of M/s. APM Terminals –Mumbai located at Parking Area No 4, Village- Nhava Sheva, Taluka- Uran, Distt. -Raigad., Maharashtra of M/s. Jawaharlal Nehru Port Trust. as a place for loading of export goods subject to the strict observance of the Provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs, Jawaharlal Nehru Customs House, from time to time.

Further, under Section 8(b) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General) hereby specify the limits of the Customs Area comprising the above Parking Plaza/Holding Area of M/s. APM Terminals –Mumbai located at Parking Area No. 4, Village- Nhava Sheva, Taluka- Uran, Distt. -Raigad., Maharashtra admeasuring approximately 38000 SQM, as under:

EAST : Service Road joining Tank Farm Road with NH 348 (JNPT Road)
WEST : Service Road with New Flyover
NORTH : Indian Oil Tank Farm Road (Service Road parallel to NH 348)
SOUTH : Tank Farm Road

Further, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby appoint M/s. APM Terminals Pvt. Ltd –Mumbai to be the Custodian of the Export Cargo brought into said Parking Plaza/Holding Area of M/s. APM Terminals Pvt. Ltd –Mumbai (APMT/GTI), located at Parking Area No. 4, Village- Nhava Sheva, Taluka- Uran, Distt. -Raigad, Maharashtra, for examination, registration of goods, inspection and

completion of other Customs formalities till exportation through any of the Port Terminals in the jurisdiction of JNCH.
