NOTIFICATION NO. 07/2016

The area admeasuring 41882 SQM of Container Freight Station of M/s. SBW Logistics Pvt. Ltd., located at Gutt No.55, Village-Khairane, Taluka- Panvel , Distt. -Raigad., Maharashtra was declared a Customs Area under Section 8 of the Customs Act, 1962 vide [Notification No. 07 /2012](#) dated 04 .06.2012. Further, the custodianship of M/s SBW Logistics pvt. Ltd. had been extended for a period of 02 years under section 45 (1) and 141(2) of the Customs Act 1962 in continuation with Notification No. 08/2012; vide Notification No. 06/2014 dated 19.06.2014 vide Commissioner of Customs (Export) order vide F. No. S/5-Gen-01/2009-10 CFS M CELL dated 19.06.2014.

3. Now, in exercise of the powers conferred on me under Section 45 (1) and 141(2) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. SBW Logistics Pvt. Ltd. to be the Custodian of the imported goods received at the Container Freight Station of M/s. SBW Logistics Pvt. Ltd admeasuring total area of 41882 SQM until these are cleared for Home Consumption or are warehoused or are transshipped in accordance with the provision of chapter VIII of the Customs Act, 1962. Similarly M/s. SBW Logistics Pvt. Ltd. will also be Custodian of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port, subject to the following conditions:

4. Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Areas Regulations 2009”. I, Subhash Agrawal, Commissioner of Customs (General) hereby approve M/s. SBW Logistics Pvt. Ltd. as a “Customs Cargo Services Provider” for the entire Customs Area of 41882 SQM of the CFS M/s. SBW Logistics Pvt. Ltd., located at Gutt No.55, Village-Khairane, Taluka- Panvel , Distt. -Raigad., Maharashtra notified as Customs area vide [Notification No. 07 /2012](#) dated 04.06.2012 subject to the following conditions.

I. The Custodian M/s. SBW Logistics Pvt. Ltd. approved as Customs cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the Rules of the “Handling of Cargo in Customs Area Regulations, 2009”, other Regulations, Notifications, Orders issued there under.

2. The duration of the appointment M/s. SBW Logistics Pvt. Ltd. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain for five (5) years in continuation with Notification No.

06/2014 dated 19.06.2014 unless otherwise suspended/revoked/cancelled prior to the expiry of the said period.

3. The approval is subject to the production of the Final Fire NOC issued by the Maharashtra Fire Department before the expiry of the Provisional Fire NOC valid upto 31.12.2016.
4. As and when required, the CCSP should provide office space for scanning of Import/Export documents.
5. The Commissioner of Customs (General) shall have the right to review the approval as 'Customs Cargo Service Provider' before the completion of five years for failure to comply with the provisions of the Customs Act,1962 in general and/or of "Handling of Cargo in Customs Area Regulations, 2009" in particular.
