CFS NOTIFICATION NO.10/2017

The area measuring approx. 52990 SQM of Container Freight Station of M/s. Sarveshwar Logistics Services Pvt. Ltd, located at Village- Dighode, Post:Dighode, Taluka: Uran, Distt: Raigad, Maharashtra was declared as a 'Customs Area' under Section 8 of the Customs Act, 1962 vide Notification No. 11/2016 dated 06.12.2016.

2. Now, in exercise of the powers conferred on me under Section 45 (1) and 141 (2) of the Customs Act, 1962, I, Utkaarsh R Tiwaari, Commissioner of Customs (NS-G), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva, hereby appoint M/s. Sarveshwar Logistics Services Pvt. Ltd. to be the 'Custodian' of the imported goods received at the Container Freight Station of M/s. Sarveshwar Logistics Services Pvt. Ltd, Village- Dighode, Post:Dighode, Taluka: Uran, Distt: Raigad, Maharashtra, until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962 for the entire Customs Area of 52990 SQM. Similarly, M/s. Sarveshwar Logistics Services Pvt. Ltd. will also be the 'Custodian' of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Area Regulations, 2009", I, Utkaarsh R Tiwaari, Commissioner of Customs (NS-G), hereby approve M/s. Sarveshwar Logistics Services Pvt. Ltd. as a "Customs Cargo Service Provider" for the entire Customs Area of 52990 Sq. Mtr of the CFS M/s. Sarveshwar Logistics Services Pvt. Ltd. subject to following conditions:

(i) The Custodian M/s. Sarveshwar Logistics Services Pvt. Ltd. approved as Customs cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962, Handling of Cargo in Customs Area Regulations, 2009” and other Regulations, Notifications, Orders issued under Customs Law or any other Law.

(ii) The duration of the appointment of M/s. Sarveshwar Logistics Services Pvt. Ltd. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain for Two (2) years from the date of issue of this Notification, unless otherwise suspended/revoked/cancelled prior to the expiry of the said period.

(iii) As and when required, the CCSP should provide office space for scanning of Import/Export documents.

(iv) The Commissioner of Customs (NS-G) shall have the right to review the approval as ‘Customs Cargo Service Provider’ before the completion of Five years for failure to comply with the provisions of the Customs Act,1962 in general and/or of “Handling of Cargo in Customs Area Regulations, 2009” in particular.
