NOTIFICATION NO. 12/2014

The area admeasuring 94668.66 Sq mtr. of Container Freight Station of M/s TransIndia Logistic Park Pvt. Ltd. situated at Village Khopta, Post Koproli, Tal. Uran, Distt. Raigad was declared as Customs Area under section 8 of The Customs Act, 1962 vide Notification No. 09/2012 dated 30.08.2012 and M/s TransIndia Logistic Park Pvt. Ltd was declared as ‘Custodian’ of the notified area i.e. the CFS vide [notification no. 11/2012](#) dated 05.09.2012 for 2 years issued under section 45 (1) and 141 (2) of The Customs Act, 1962.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (Export), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s TransIndia Logistic Park Pvt. Ltd to be the ‘Custodian’ of the imported goods received at the Container Freight Station of M/s TransIndia Logistic Park Pvt. Ltd. until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Customs Act , 1962. Similarly, M/s TransIndia Logistic Park Pvt. Ltd will also be the ‘Custodian’ of the Export Cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Areas Regulations 2009”. I, S.H. Hasan, Commissioner of Customs (Export) hereby approve M/s TransIndia Logistic Park Pvt. Ltd as a ‘Customs Cargo Services Provider’ for the said CFS M/s TransIndia Logistic Park Pvt. Ltd Subject to following conditions:

1. The Custodian M/s TransIndia Logistic Park Pvt. Ltd. approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the “Handling of Cargo in Customs Areas Regulations 2009”, other regulations, notifications, orders issued there under.
2. The duration of the appointment of M/s TransIndia Logistic Park Pvt. Ltd. as ‘Custodian’ and as the ‘Customs Cargo Services Provider’ shall remain for five (5) years from the date of issue of [notification no. 11/2012](#) i.e. 05.09.2012.
3. The Commissioner of Customs (Export) shall have the Right to review the approval as ‘Customs Cargo Services Provider’ before the completion of five years for failure to comply with any of the Regulations of the “Handling of Cargo in Customs Areas Regulations 2009”.
