NOTIFICATION NO. 13/2015

The area admeasuring 9 acres (i.e. 36,000 SQM aprox.) Of Container Freight Station situated at Jasai Village , Opp. Chirle Village, Taluka Uran, Maharashtra of M/s. Vaishno Logistics Yard was declared as a Customs Area under Section 8 of The Customs Act, 1962 vide Notification no 31/2010 dated 06.10.2010 as amended from time to time. M/s. Vaishno Logistics Yard was appointed as a 'Custodian' & 'Customs Cargo Service Provider' for the said CFS area vide notification no. 16/1012 dated 07.11.2012. Further, an additional area of 4815 SQM was notified as a 'Customs Area' under Section 8 of The Customs Act, 1962 vide Notification no 12 / 2015 dated 19.03.2015. Thus the total CFS area becomes 40,815 SQM.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby appoint M/s. Vaishno Logistics Yard to be the Custodian of the imported goods received at their Container Freight Station admeasuring approx. 40,815 SQM until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act , 1962. Similarly, M/s. Vaishno Logistics Yard will also be the Custodian of the Export Cargo brought into said Container Freight Station, including the additional area, for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, S.H. Hasan, Commissioner of Customs (General) hereby approve M/s. Vaishno Logistics Yard as a 'Customs Cargo Services Provider' for the abovementioned Container Freight Station of M/s. Vaishno Logistics Yard, including the additional area, subject to following conditions:

1. The Custodian M/s. Vaishno Logistics Yard approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the "Handling of Cargo in Customs Areas Regulations 2009", other regulations, notifications, orders issued there under.
2. The duration of the appointment of M/s. Vaishno Logistics Yard. as 'Custodian' and as the 'Customs Cargo Services Provider' shall remain for five (5) years from the date of issue of the original notification no 16/2012 dated 07.11.2012.

3. The Commissioner of Customs (General) shall have the Right to review the approval as 'Customs Cargo Services Provider' anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations 2009 or as per the directions of the Government of India.
