## CFS NOTIFICATION NO. 13/2016

The area admeasuring 94668.66 SQM of Container Freight Station of M/s. TransIndia Logistic Park Pvt. Ltd., located at Village-Khopta, Post-Koproli, Taluka-Uran, Distt. -Raigad, Maharashtra was declared a Customs Area under Section 8 of the Customs Act, 1962 vide [Notification No. 09 /2012](#) dated 30 .08.2012 and M/s. TransIndia Logistic Park Pvt. Ltd. was declared as ‘Custodian’ of the notified area vide CFS Notification No. 11/2012 dated 05.09.2012 for 2 years under section 45 (1) and 141(2) of the Customs Act 1962.

2. M/s. TransIndia Logistic Park Pvt. Ltd. vide letter dated 22.08.2016 have informed that they have sold their Container Freight Station to M/s. Allcargo Logistics Limited pursuant to Business Transfer Agreement dated 11.08.2016.

3. Now, in exercise of the powers conferred on me under Section 45 (1) and 141(2) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava Sheva, hereby appoint M/s. AllcargoLogistics Ltd.to be the ‘Custodian’ of the imported goods received at the Container Freight Station of M/s. Allcargo Logistics Ltd until these are cleared for Home Consumption or are warehoused or are transhipped in accordance with the provision of chapter VIII of the Customs Act, 1962. Similarly M/s. Allcargo Logistics Ltd. will also be ‘Custodian’ of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

4. Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Areas Regulations 2009”. I, Subhash Agrawal, Commissioner of Customs (General) hereby approve M/s. Allcargo Logistics Ltd. as a “Customs Cargo Services Provider” for the entire Customs Area of 94668.66 SQM of the CFS M/s. Allcargo Logistics Ltd. subject to the following conditions:

I. The Custodian M/s. Allcargo Logistics Ltd. approved as Customs cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and “Handling of

Cargo in Customs Area Regulations, 2009”, as amended and other Regulations, Notifications, Orders issued there under.

2. The duration of the appointment M/s. Allcargo Logistics Ltd. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain for five (5) years from the date of issue of this notification unless otherwise suspended/revoked/cancelled prior to the expiry of the said period.
3. As and when required, the CCSP should provide office space for scanning of Import/Export documents.
4. The Commissioner of Customs (General) shall have the right to review the approval as ‘Customs Cargo Service Provider’ before the completion of five years for failure to comply with the provisions of the Customs Act,1962 and/or of “Handling of Cargo in Customs Area Regulations, 2009”, as amended.
