The area admeasuring 36456 SQM Container Freight Station located at Village- Palaspe, Mumbai-Goa Highway, Taluka- Panvel, Distt. -Raigad., Maharashtra of M/s. Take Care Logistics Park (India) Pvt. Ltd. was declared as a Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 29/2015 dated 14.07.2015.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Principal Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby M/s. Take Care Logistics Park (India) Pvt. Ltd. to be the Custodian of the imported goods received at Container Freight Station of M/s. Take Care Logistics Park (India) Pvt. Ltd. located at Village- Palaspe, Mumbai-Goa Highway, Taluka- Panvel, Distt.- Raigad, Maharashtra until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act, 1962. Similarly, M/s. Take Care Logistics Park (India) Pvt. Ltd. will also be the Custodian of the Export Cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Areas Regulations 2009”. I, S.H. Hasan, Principal Commissioner of Customs (General), hereby approve M/s. Take Care Logistics Park (India) Pvt. Ltd. as a ‘Customs Cargo Services Provider’ for **the above mentioned Container Freight Station of M/s. Take Care Logistics Park (India) Pvt. Ltd. subject to following conditions:**

1. The Custodian M/s. Take Care Logistics Park (India) Pvt. Ltd. approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules of the “Handling of Cargo in Customs Areas Regulations 2009”, other Regulations, Notifications, Orders issued there under.
2. The duration of the appointment of M/s. Take Care Logistics Park (India) Pvt. Ltd. as ‘Custodian’ and as the ‘Customs Cargo Services Provider’ shall remain for two (2) years from the date of issue of this Notification.
3. The Principal Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Services Provider’ before the completion of two years for failure to comply with any of the Regulations of the “Handling of Cargo in Customs Areas Regulations 2009” or as per the directions of the Government of India.
