- 4. Any bid offering the price of the goods below the reserved price i.e. Rs.65,500/- will be out-rightly rejected.
- 5. Prospective bidders of such lots of hazardous waste/scrap batteries/ e-waste should be registered e-waste processor duly authorized by concerned Pollution Control Board, valid on the date of e-Auction and on the date of delivery, as recycler/pre-processor agency.
- 6. Tender/Bids will be opened at 03.00 pm on 17.11.2023 in the office of the Dy. Commissioner of Customs, CHS, Jawaharlal Nehru Custom House, Nhava Sheva, Navi Mumbai-702. The highest bidder will be awarded the bid materials. The bidders are welcome to come and witness the opening of tender/bids.
