MINUTES OF MEETING WITH TERMINAL OPERATORS AND PARTICIPATING GOVERNMENT AGENCIES (PGAs) ON THE ISSUES OF "MAKING ONWHEEL SAMPLING FACILITY FUNCTIONAL TO DPD CLIENTS" [HELD ON 06.11.2017].

The DPD meeting held on 06.11.2017 was chaired by Shri Subhash Agrawal, Commissioner of Customs, NS- III and attended by Shri Dhirendra Lal, ADC, Shri C.P. Singh, DC and Shri Praveen Kumar, AO. The meeting was attended by the following authorized persons of different stakeholders:-

- 2. At the outset, the Chairperson welcomed all the members of the Participating Government Agencies (PGAs), representatives of NSICT & members of trade and discussed the issues relating to "on wheel sampling" of goods from Terminal areas". Chairperson informed the members that one of the Terminal Operators i.e. NSICT (M/s DP World) has shown willingness to provide "exclusive area for sampling" for DPD FCL containers", wherein samples can be drawn by the Customs/ PGAs and subsequently the containers can be allowed to move from Port to desired destination under DPD mode.
- 3. As the sampling process involves participation of different PGAs, Customs have requested these participating government agencies vide letter dated 13.10.2017 to examine the issue and explore possibilities for sampling in "exclusive area" inside Terminals. Attention of PGAs during meeting was also drawn towards this letter.
- 4. During discussion, views expressed by representatives of different participating government agencies (PGAs) are as under:-
- (i) Animal Quarantine Regional Officer, Animal Quarantine have informed that before collection of samples from DPD FCL containers, they have to check documents like Sanitary Import Permit, Health Certificate etc. They draw samples from only those consignments which are accompanied with valid documents, failing which they are fit to be deported/destroyed and the complete process takes around 7 to 8 days from filing the application. Till then the containers are required to be kept in Customs Bonded

Area. They submitted that consignments requiring NOC from Animal Quarantine should not be allowed

to clear under "no-use bond".

(ii) FSSAI: - Deputy Director, FSSAI informed that it takes 7-8 days to release the test reports after

submission of application before FSSAI. They have given their nod for "on wheel sampling" however,

insisted that application should be completed by the Importer in all aspects before sampling at Terminals.

Regarding availability of FSSAI officer for drawal of sample, they submitted that they will take up the

issue with their head office.

It was informed by the trade that present system of payment online (as is being accepted by

Textile Committee) can be started to avoid delays on account of payments.

(iii) Plant Quarantine: - They have also given their consent for on wheel sampling from the Terminal

subject to compliance of submission of required documents and advance payment. However, they stated

that the NOC/Import release order cannot be issued until all laboratory requirements fulfils. They

submitted that consignments requiring NOC from Plant Quarantine should not be allowed to clear under

"no-use bond". However, items where they are giving provisional NOC or giving NOC within a day may

be considered for on wheel sampling. Finally, they conveyed that they will check the position from their

head office and revert.

(iv) Assistant Drug Controller: Representative of Assistant Drug Controller informed that they are

facing staff crunch and therefore, they will intimate about authorizing Customs to draw samples from for

"DPD FCL Containers" at consignments from Port ["exclusive area for sampling" for DPD FCL

containers"] after discussing with their higher authorities.

(v) RFCL: Assistant Director, RFCL informed that they have already referred the issues with their

Ministry proposing Customs to draw the samples from the Consignments and to forward the samples for

analysis to their Mumbai Laboratory. He has also informed that Customs may take up the issue directly

with their Ministry.

(vi) NSICT: Representative of NSICT assured that they are ready to provide all the requirements of

PGAs and Customs for on wheel sampling inside Terminals.

This issues with the approval of the Commissioner of Customs NS-III.
