2. This order is issued by the placement Committee which was formed by the Chief Commissioner of Customs, JNCH vide F.No. CCC/VJ/Misc-01/2018/CCO M-II dated 21.05.2018.

3. The postings of Appraisers who are continuing in JNCH are issued on the basis of personal interaction of Placement Committee with them and the posting of Appraisers coming from other Zone have been done taking into account their history of postings.

4. The performance of the Appraisers posted by this order will be reviewed after one month and changes, if any, thereafter will be made.

5. The Officers who have not joined in the Mumbai Customs Zone-II shall report to Appraising Main (Import), NS-I on their joining.

6. The officers posted in Appraising Main (Import) shall look after the charge of newly formed 'Centralised Original Document Verification Cell' till further order.

7. The officers who are getting relieved within JNCH and their relievers are also coming from JNCH shall be Stand Relieved by 08.06.2018 without waiting for their relievers and no separate relieving orders would be required from concerned section. A compliance report of officers relieved should reach the Joint Commissioner of Customs, Appraising Main (Import) by the concerned Deputy/Assistant Commissioner in charge of the section by 15.06.2018. Non-compliance of the above would be viewed seriously.

8. It shall be ensured by officers being relieved that "a proper handing over Note" is prepared enumerating pendency and important items of pending work and handover the same to "relieving officer" (with copy to concerned JC/ADC and PA to Commissioner) on the date of relieving.
