## **ESTT. ORDER No. 08/2020**

CBIC letter F No. C 50/30/ 2020- AD II ST. 19.03.2020 has communicated Office Memoranda No. 11013/9/2014-Estt (A-III) dated 17.03.2020 and 19.03.2020 issued by the Department of Personnel and Training, regarding preventive measures to contain the spread of COVID-19.

- Para vi of the DOPT OM dt. 19.03.2020 states :
- "(vi) These instructions shall not apply to the officers and employees engaged in essential / emergency services and those directly engaged in taking measures to control spread of COVID 19."
- 3. This office is engaged in essential services, as defined.
- 4. However, taking into account the essence of the preventive measures being taken to contain the spread of COVID 19 by the Centre and the State Government, it was considered to allow to 50 % of the staff in certain back end sections of the Customs Mumbai Zone II (as detailed in the Annexure "A"), the option to work from home temporarily. These staff are named in Annexure A and the permissible dates for work from home option is indicated. If they choose to work from home on any of these dates, it is conditional to them-
- (i) they make suitable arrangement such that they can actually work from home.
- (ii) staying at home.
- (iii) staying in constant touch with their controlling officer.
- (iv) being available on telephone and by electronic means of communication at all times; and
- (v) they attend office, if called for any exigency of work.
- 5. Additional / Joint Commissioners of their Sections will closely monitor the working of the Sections and officers working from home to ensure that no aspect of work is adversely affected and to ensure that the particular staff is recalled no sooner the need is anticipated.
- 6. This order applies only in respect of staff named in the Annexure A

7. This issues with the approval of Commissioner of Customs, NS-General, JNCH, Nhava- Sheva and in consultation with Commissioner NS (I), NS (III), and NS (V).




