GENERAL COMMISSIONERATE

I. AGENDA POINTS RAISED BY IMC

<u>कार्यबिन्दु संख्या 1./ AGENDA POINT NO. 1</u>:- Exploitation of EXIM industry by continued recovery of Weighment charges though the matter was resolved in July 2022, the CFS' operator refuse to abide by the Commissioner's order and continue to exploit the EXIM industry.

Please find copy of the letter dated 01.03.2023 addressed to Mr. D.S. Garbyal, Commissioner of Customs, Imports General along with 10 enclosures.

प्रतिक्रिया/Response: The Chair directed to all the CFSs to send the list of all the heads in which they are charging the consignee. The list will be examined and if any irrelevance is noticed, the Customs will intervene as this is against the spirit of trade facilitation and Ease of Doing business.

<u>कार्यविन्दु संख्या 2./Agenda Point No. 02</u>:- Recovery of various charges by Shipping Lines which should not be borne by the shippers is being recovered from the Consignee.

We enclose herewith copies of various Invoices being raised by Shipping Lines wherein charges raised which should not be borne by consignee as they fall part of Sea Freight on which Custom duty is payable and also these sums result in high handling cost which is against the interest of EXIM industry.

II. <u>Agenda points proposed by Brihanmumbai Custom Brokers Association</u> (BCBA): -

<u>कार्यबिन्दु संख्या 1./Agenda Point no. 01:-</u> Need to facilitate Export trade by permitting buffer movements from CPP to CFS

Further to our various communications, with a view to provide consistent Ease of Doing Process for Export trade, we request that Export trade be kindly allowed to shift containers to their Choice of CFS for Buffer movement. In the recent past, movement of containers to Buffer area has become erratic and is not consistent. On and Off, there has been regular instances of congestion which in recent past has led to shut out of hundreds of export containers.

We refer to JNPA Letter Ref. JNP/CMT-BUFFER/2023/1126 dated 8.3.2023 which is specifically covering up this aspect and has recommended shifting of containers to exporter's choice of CFS in order to facilitate timely movement of export cargo and avoid congestion. It may not be out of place to mention that on import side, for DPD containers also, choice of CFS is permitted. This has helped considerably to de-congest the Port terminals.

In view of the financial year ending and repeated instances of congestion, we request for issuance of necessary orders to facilitate export trade.

EXPORT COMMISSIONERATE

We would like to thank JN Customs for issuance of PN No 19/2023 dated 27.2.2023 regarding examination of Export goods at Export Docks in two shifts. However, it has been brought to the notice of the Association that the said PN is still not followed diligently at JWR CFS, thereby leading to delay in clearance and increase in transaction cost.

We request you to kindly intervene and issue necessary instructions to field formation for strict compliance of the said PN in larger interest of Export Trade at JNCH.

<u>प्रतिक्रिया/Response:</u> The Chair stated that whenever such an issue arises, it can be brought to the notice of Shri Tariq Mabood, Additional Commissioner of Customs, Export immediately.

II. AGENDA POINTS RAISED BY WISA

कार्यबिन्दु संख्या 1./Agenda Point no. 01 :- Review and withdrawal of old and irrelevant PN:

A case in point is PN 184/2016 which was issued post introduction of RMS-FC when details of scanning list were not visible to OOC officers. Now since the OCC officers are able to know selection of containers, said PN is not relevant now and needs to be withdrawn.

प्रतिक्रिया/Response: The Chair stated that BCBA may provide the list of those Public Notice which appears to be irrelevant/obsolete. All those Public Notice in the list provided by BCBA will be reviewed by the department and the necessary action will be taken.
