### **New Points**

#### **Points by BCBA:-**

##### **Point No.1: LEO time and date is required on the Shipping Bill**

For larger benefit of the export trade and ascertaining time wise activity to the export trade, BCBA requested that timing of following activity be captured in the ICEGATE status screen.

BCBA would like to state that on import side, ICEGATE portal already has such parameters specifically covered time-wise. Hence, they request that the same should be available on the export side also.

- Assessment
- DC release
- Registration of Documents for LEO
- Feeding Examination report and LEO

**Discussion:** The Chair informed that CEAC was constituted in order to have uniformity in assessment as per public Notice No. 64/2017 that inter-alia deals in the first time export, conversion of schemes, the assessment, CTH, valuation, drawback, export benefits of Shipping Bills which are marked by EDI system automatically. The matter of incorporation of time of assessment, DC release, registration of documents for LEO, feeding examination report and LEO in the ICEGATE status screen will be taken up with DG (Systems).
