2. At the outset the Chairman welcomed all the members and discussed the agenda points relating to import commissionerates followed by agenda points of the export/audit commissionerates.

The discussion & decision in respect of agenda points pertaining to NS-G, NS-II & NS-IV commissionerates are as under:-

New Points

Points from BCBA:-

Point No.1: Required monsoon preparedness at all parking plaza:-:-

Discussion: The Chair informed that management of each Parking Plaza is responsible to provide all necessary requirements at the time of rainfall. It is also requested to specify what type of facility which is to be extended so that this office may write to all Parking Plazas management accordingly.

A meeting to be convened by Deputy Commissioner/Joint Commissioner parking plaza alongwith the terminal management asking them to ensure basic facilities are arranged by them in general and specifically during rains/monsoons for ensuring smooth exports.

Point No.2: Repeated power failure at parking plaza:-

Processing of export shipments are affected due to repeated power failure at parking plaza.

We kindly request Authorities to kindly look into the matter for uninterrupted connectivity for processing of export shipments.

Discussion: The Chair informed that the letter regarding repeated power failure has already been issued to all concerned Administration/Custodian of all Parking Plazas, as per Cargo Handling Rules 2009, the Custodian is responsible for providing such power back up. There was some issue with electricity hub of NSICT and the terminal management of NSICT has ensured that they replacing the same within a week's time.

Points from Audit Commissionerate, JNCH:-

Point No.3: BCBA directory updation:-

Various consultative letters are issued to importers/exporters asking for short payment duty etc. and a copy of each such letter is marked to Customs Broker. However many a times the letters are received back as the same remains undelivered at Customs Broker's registered address. The audit officer then make phone calls to the Customs Brokers concerned but many-a-times the phone number either don't work or the employee who pick up the call informs that he is no longer working with the Customs Broker. In audit, the department makes an attempt to recover short payment or get clarification without going into the litigation by way of issuance of SCN and the Customs Brokers are expected to co-operate with the department for early resolution of the issue. However the non-availability of proper address and contact numbers of responsible persons makes this exercise for department difficult. It is thus requested that BCBA must keep updating their directory on regular basis and keep presenting the same to this Customs House.

Discussion: The Chair directed that the BCBA must keep updating their directory on regular basis and keep presenting the same to this Customs House.
