The meeting was Chaired by Shri D.K. Srinivas, Commissioner of Customs (NS-I & III). Shri R.P. Raheja, Indirect Tax Ombudsman-Mumbai also attended the meeting.

- 4. At the outset the Chairman welcomed all the members and introduced Shri R.P. Raheja, Indirect Tax Ombudsman-Mumbai to the members of Committee. Shri R.P. Raheja elaborated about the functions and the mechanism of grievance-redressal adopted by the office of the Indirect Tax Ombudsman-Mumbai (ITOM) to the Members of the committee. He requested the Trade to popularize about this institution amongst the Trade and Industry, so that, they may approach the Office of the Ombudsman to get their grievances addressed suitably. He also sougth feedback from the members. The various members interacted with the Ombudsman to get an understanding about the benefit to trade & industry from this noble institution. Shri Raheja concluded his speech with the thanks to Chair for inviting him in PTFC.
- 5. After this the, chairman directed to start the deliberations on the agenda of the meeting. The agenda relating to Import Commissionerates were discussed first, and then following agenda of the Export Commissionerates were deliberated upon:

## 6. OLD POINTS

### (a). Non observance of Facility Notice No. 50/2015 by CFSs at JNPT.

**Background:** The representative of BCHAA had informed that instructions issued by JNCH vide Facility Notice No. 50/2015 dated 29-06-2015 wherein it was directed that the CFSs start online payment and billing, were not being followed by CFSs. Also, there was considerable delay, lack of transparency, lack of uniformity in the tariff laid by the CFSs.

**Discussion:** The Committee was informed that a meeting was held on 05.04.2016 with the members of CFSAI and BCHAA. The meeting was chaired by the Chief Commissioner of Customs, Mumbai Zone-II who had directed the CFSs about the early implementation of e-invoicing/e-payment. The Committee was assured that action will be taken against CFSs which are not complying with the instructions contained in Facility Notice No. 50/2015.

The Commissioner directed that the matter should be referred to CCFC.

(Point Closed)

#### 7. New Point

Point No. 1: Post Shipment Amendment under Section 149 in MEIS Shipping Bill: The BCHA has informed that cases which falls under the category of amendment under Section 149, such shipping bills cannot be re-transmitted to DGFT. The post shipment amendments in all scheme related documents such as MEIS, AA does not get transmitted to DGFT. If under MEIS shipping bill and exporter have claimed text declaration as required in policy/procedure, however, he has not mentioned "yes" in reward item block, there is no provision in system to allow amendment and to get such S/bs transmitted to DGFT.

Similarly in other schems, if post shipment amendment is permitted by customs and a certificate is issued in this regard, such shipping bills do not get retransmitted to DGFT. They informed that this matter has already been discussed in past, however, no solution is coming forth. Exporter faces lot of hardship due to this technical problem.

**Discussion:** Shri Akhilesh Pandey, Additional Commissioner of Customs informed the members that a PN No. 94/2015 has been issued in this regard and an Advisory has also been published on the website of Jawaharlal Nehru Custom House for the benefit of Trade and Customs Brokers. He also informed that all such shipping bills where the exporter has declared 'Yes" in the "reward item" field, have already been transmitted to DGFT and there is no pendency. In cases where Exporter has not mentioned "Yes" in this field, but has declared his intention to claim Chapter 3 benefit on the body of the shipping bills, such shipping bills are to be transmitted by DG, Systems. In respect of such shipping bills, trade/CB may write to ICEGATE on their e-mail si@helpdesk.icegate.gov.in.

The representative of BCHAA stated that the issue is not limited to the retransmission of MEIS shipping bills, but in case of other shipping bills such as Advance Authorization or EPCG where there are certain typographical errors, the amendment allowed by the Department are not being transmitted to DGFT.

The Chairman assured the members that the issue will be examined in consultation with DG, Systems as it requires the modifications in ICES.

- **8. Re-constitution of PTFC:** The trade was informed that a Public Notice No. 52/2016 dated 18.03.2016 has been issued for re-constitution of PTFC (Exports) and in response to this, following Associations/entities have expressed their willingness to participate in PTFC Meetings:

  - ii. CSLA
  - iii. Metal Recycling Association of India
  - iv. Bombay Metal Exchange Ltd.
  - v. Women Custom Brokers & Freight Forwarders

The members of committee enquired whether they are required to apply again for the membership of PTFC as they are already member of present committee. The Chairman requested all the members to apply again and provide the requisite information about their organizations/associations. The chairman requested that all members may send their request for membership before 15<sup>th</sup> May, 2016 to enable the re-constitution of PTFC before next meeting.

- 9. Shri Nilkanth N. Shelke, Additional Commissioner of Customs informed the committee that in order to bring further transparency and fairness in public dealing and to strengthen the security of the Custom House, the officers have been instructed to ensure that the person interacting with them are authorized persons of importer/exporter or authorized Customs Brokers. The one day pass to enter into the premises of Custom House will also be issued only after confirming the requirement to issue the pass with the concerned office/department. Steps have also been taken to stop the misuse of one day entry passes. He requested the members present to sensitize the Trade/Importer/Exporter as the matter pertains to national security.
- 10. The next Export PTFC meeting is scheduled on **26<sup>th</sup> May**, **2016** at 11:30 AM in Conference Hall, 5<sup>th</sup> Floor, Jawaharlal Nehru Custom House, Nhava-Sheva.
