Ms. Hemlata Rai, Addl. Commissioner of Customs, Appraising Main (Import) JNCH, started the discussion on the agenda points of the meeting relating to the import.

3) कार्यबिन्दु/AGENDA POINTS:
CSLA के द्वारा उठाया गया कार्यबिन्दु /Agenda Points raised by CSLA

1. कार्यबिन्दु संख्या 01/Agenda Point No.01: Inconsistent Performance of ICEGATE System

- a. ICEGATE is working slow since last two weeks. On most of the occasions IGM is not processed till 24-36 hours and when processed output files are not generated. Hence shipping lines are unable to track whether all Import BLs of IGM and all shipping bills of EGM have been accepted or not. This has become a regular issue since the last two weeks. On a few occasions matters have been brought to the notice of JNCH & ADG ICEGATE also, The matter was escalated by JNCH to ICEGATE team too but still output files have not yet been generated. We request JNCH to take up this matter with ICEGATE and request them to arrange output files of all pending IGM & EGM cases and arrange alternative options to file IGM /EGM in order to avoid last minute hassles of vessel berthing.

प्रतिक्रिया/Response:-

Commissioner of Customs, NS-I, JNCH, stated that these issues have been brought to the notice of DG System who are attending such issues promptly. However, it may be

relevant to mention that Board as well as JNCH has also been taking very proactive steps in this matter to ensure that the Trade does not face difficulties.

In addition, Additional Commissioner stated that as and when such issue arises tickets are being raised by the concerned officers as well as the importer.

2. कार्यबिन्दु संख्या 02/Agenda Point No.02: Delay experienced in Faceless Assessment at FAG Level – request for monitoring.

- a. Since past one month, several delays in Assessment at FAG are being experienced. Trade has escalated the matter under AEM, inspite of the same, delays are experienced.

प्रतिक्रिया/Response:-

Additional Commissioner, Hemlata Rai, stated that no specific incidence or instance have been mentioned in the agenda point. However, the issue is being monitored at ADC level on day to day basis, and in case any such issue is brought to the notice then the matter shall be taken up with concerned FAG for resolution of the issue. Meanwhile, the stakeholders were requested to report any specific issued faced by them.

- a. PN 184-2016 – pertaining to “Clarification in respect of “part delivery” where OOC is obtained at DPD/RMS Facilitation Centre at JNCH”
- b. PN 34/2022 issued by JNCH is not being honoured by other FAG locations. BE are being assessed finally and at time of OOC, PAG are insisting for Provisional causing delay in clearances. Request for cancellation of said PN.

प्रतिक्रिया/Response:-


With respect to P. N. No. 184/2016 dated 02.01.2017, the Chair stated that whenever such issues are faced by the stakeholders, the same should be discussed with concerned Additional Commissioner of Customs (Docks) for understanding the entire issue. And, if required, matter could be discussed with concerned Commissioner in-charge, and decision on the subject matter will be taken accordingly. Further, Additional Commissioner, Hemalata Rai, stated that the said public notice is to facilitate the trade, so may not be required to be withdrawn.

With respect to P. N. No. 34/2022 dated 17.05.2023, Commissioner of Customs, NS- I stated that said PN shall be circulated in the respective NACs to be held on 26.05.2023. The Chair observed that normally Docks Officer will raise objection only after scrutinizing the documents uploaded on e-sanchit especially regarding mismatch of supplier's name or COO etc., adding that the decision of provisional assessment in such cases appears reasonable. The Chair also suggested that whenever a PN with respect to assessment is issued by JNCH, the same shall be circulated to the concerned NAC according to the Custom Tariff Heading. All such cases can be recalled at PAG for correct assessment.
