The PTFC meeting for the month of April 2024 was held in physical mode on 25/04/2024 and was chaired by Shri. D. S. Garbyal, Commissioner of Customs (NS-General) and attended by Shri Sonal Bajaj, Commissioner of Customs (NS-V), and Shri Ashwini Kumar, Commissioner of Customs(NS-III).

Shri Ramalingeswara Rao, Assistant Commissioner of Customs, NS-I Commissionerate, JNCH, with permission of the Chair, presented the Agenda points pertaining to Imports.

**4. BCBA के द्वारा उठाया गया कार्यबिन्दु / AGENDA POINTS RAISED BY BCBA :**

कार्यबिन्दु संख्या/POINT NO.1. 100% examination orders being given in large number of cases causing delays in clearances.

**प्रतिक्रिया/Response:** The stakeholders were requested to bring to the notice of cases wherein FAG officer has given 100% examination order beyond RMS instruction to the concerned Commissioner, JNCH, for verifying from concerned FAG as to whether such orders were given with due approval of JC/ADC or otherwise. Thereafter, based on response from FAG, a suitable action will be initiated by JNCH.

(बिन्दुसमाप्त/ Point Closed)

कार्यबिन्दु संख्या/ POINT NO. 2. Erroneous Assessments at FAG causing significant delays.

**प्रतिक्रिया/Response:** The stakeholders were again requested to bring to the notice of concerned Commissioner of cases wherein FAG has resorted to erroneous assessment so that necessary action can be taken by JNCH in consultation with the FAG. Meanwhile, Chair also requested stakeholders to ensure that suitable reply be furnished to query raised by FAG at the earliest to avoid delay on their part.

(बिन्दुसमाप्त/ Point Closed)

कार्यबिन्दुसंख्या/ POINT NO. 3 Improper and unjust loading of value resulting in delays in clearances.

**प्रतिक्रिया/ Response:** The stakeholders were requested to bring such cases to the notice of concerned Commissioner for suitable action by JNCH in consultation with the FAG.

कार्यबिन्दुसंख्या/POINT NO. 4.: Delay in AEO processing especially of CB AEOs:

In the last PTFC meeting, it was informed that there is delay in Processing AEO files LO. It was advised that there is delay in CB section for receiving NOC. It is requested that AEO can verify through CBLMS portal. This will save lot of time and AEO files can be processed faster.

**प्रतिक्रिया/Response:** It was informed that total application pending under AEO-LO category as on date was 54. Out of 54, 24 applications were under scrutiny whereas in 30 cases the field visit has already been completed. Thus, 30 cases are at the final stage of processing of application. As

regards remaining 24 cases, most applications were received in the month of **February and March 2024 only.**

कार्यबिन्दुसंख्या/POINT NO. 5: Delay in issuance of TR memo from CFS. It is requested for issuance of standing order/directions to simplify and expedite the process. Due to system issue and approval up to the level of Additional Commissioner, it is taking huge time, hence the clearance is delayed up to 3 to 4 days. It is requested to update the system and in the meantime authority for approval to be given to DC docks.

प्रतिक्रिया/Response:.. The PN No.57/2021 dt.23-6-2021 was issued in the context of using/making CRCL Module as mandatory for test memo generation. And, manual test memos are allowed only with the approval of ADC/JC in those cases wherein system do not have particular CTH mapped. Accordingly, the stakeholders were requested to provide details of the CTHs/RITCs wherein **manual TM** are being generated for suitable incorporation by the Systems Directorate.

Meanwhile, the concerned ADC/JC will ensure early approval of manual TM in E-Office. The CRCL to also make efforts to identify CTHs/RITCs based on manual TM received over the last one month to send the detailed proposal for incorporating said CTHs/RITCs for online TM generation.

कार्यबिन्दुसंख्या/POINT NO. 6: Shifting of Section 49 consignment with bottle seal instead of physical escort, along with transit insurance policy

प्रतिक्रिया/Response:.. This issue will be examined by **Appraising Main (Import) for the feasibility, if any. The meeting should be convened by AM within next fortnight.**

कार्यबिन्दुसंख्या/POINT NO. 7: Non-assignment of BE under RMS being frequently experienced resulting in BE being assigned for assessment causing huge delays in clearances.

प्रतिक्रिया/Response:.. The said issue has already been flagged before DG systems. Meanwhile, stakeholders were requested to let us know the key issues pertaining to ICES/ICEGATE/NCTC which are still pending resolution for the JNCH to organize a physical meeting wherein representatives of ICES/ICEGATE/NCTC will be present. The Appraising Main will coordinate this.

**कार्यबिन्दुसंख्या/POINT NO. 8:**

Request to allow delivery without OOC and gate copy incase of erratic working of ICEGATE. It has been brought to notice of the Association that when there is system issue, deliveries are kept on hold for OOC and gate copy. Whenever OOC copy is not generated due to system issue, but OOC has been done in system (and can be verified) in such cases, delivery may be permitted.

**प्रतिक्रिया/Response:** The issue will be examined separately in a meeting to be organized by Appraising Main (Import) with **representatives from BCBA, CFS association and preventive cadre in next fortnight.**

**5. CSLAके द्वारा उठाया गया कार्यबिन्दु /AGENDA POINTS RAISED BY CSLA :**

**कार्यबिन्दुसंख्या/POINT NO. 1:Scanning Issue**

**Scanning Issue:** Import ICD Containers are selected for Mobile & D scanning, One of the D scanner is outside the port gate. In order to avoid huge additional charges, presently Import ICD Containers marked for D-1 scanning (Outside the port area) are allowed for mobile scanning inside the port terminal in the working days. As D-2 scanning option is available inside BMCT terminal as well, The Import ICD Containers of other port terminal selected for D scanning should be allowed for D scanning at BMCT terminal. The tailor carrying scanning selected containers should be allowed to bring containers at D-2 scanning site at BMCT & vice versa through internal express / TP 3 road basis on SMTP /IGM hard copy document & customs scanning list. As per standard process the scanning stamp (CLEAR/ SUSPICIOUS) may be given on SMTP / IGM hard copy. This additional option will reduce at least two days of dwell time on weekends and assist faster evacuation of containers.

**प्रतिक्रिया/Response:** This issue is already dealt with and the matter is already resolved. If the issue still persists, the same be brought to the notice of the concerned Commissioner for taking it up with the NCTC, if required, for which the trade should not wait for next PTFC meeting.
