### 4. The following old points pertaining to the last PTFC meeting held on 26.03.2015 were taken up for discussion:-

**Point 4.1:** Shri Nimish Desai, Western India Shippers' Association (WISA), raised the issue of

amendment in IGM with regard to SEZ clearance without involving shipping Lines. He said that the points be reconsidered.

**Reply:** It was decided that a meeting would be held in the chamber of Shri Alok Agarwal, Jt. Commissioner of Customs along with DC in-charge of Import Noting Section, Shri Nimesh Desai and Shipping Agents to finally resolve the issue.

**5. The following fresh points came up for discussion in the present PTFC meeting:**

**Point 5.1:** Shri Rajasekhar Ramadorai, UPL Limited, has raised an issue regarding insistence of packaging verification by Customs at the time of export of insecticide, pesticide, weedicide registered under Central Insecticide Act. In his e-mail he has requested “that Customs should restrict their discussion on ensuring that the product registered and product exported are not different from the registration issued, and getting into discussions on packaging when it is not specified should be avoided so that there are no delays in processing of documents.”

**Reply:** Shri Rajasekhar Ramadorai was informed that comments on the issue have been called for from the AC/DC at Punjab Conware CFS and that the same would be conveyed as soon as received.

**Point 5.1:** Shri C.S. Murty, Secretary General, MANSA vide his e-mail dated 23.03.2015 had requested for issue of standing order/public notice for compliance of Board’s Circular No 02/2015-Cus dated 15.01.2015. Shri Murty has enclosed a copy of standing order dated 16.01.2015 issued by Commissioner of Customs (Airport), Kolkata in compliance to the above mentioned Board’s Circular.

**Reply:** Standing Order No. 11/2015 dated 21.04.2015 has been issued by Pr. Commissioner of Customs (N.S.-Gen & II), at JNCH, in this regard.

**Point 5.2:** Ms. Shyamali Banarjee, Joint Director, FIEO in her e-mails dated 17.04.2015 and 20.04.2015 has forwarded a list of duty drawback outstanding statement of M/s. IPCA Laboratories, M/s. Archana Ampoules and M/s. Soccer India regarding pending drawback claims.

**Reply:** DC / DBK informed that drawback is pending for verification of BRC in the case of M/s. IPCA and Archana Ampoules, whereas Scroll has already been generated in the case of M/s. Soccer India.
