The Chairman welcomed all the members present for the meeting. The Commissioner highlighted various steps taken during the Trade Facilitation Fortnight held during 19.01.2012 to 02.02.2012 and the results achieved. The Chairman congratulated Shri Anjani Kumar, Additional Commissioner and Shri Nilesh Gandhi ,President, BCHAA on behalf of the committee for being awarded Certificate of Appreciation by the W.C.O for their contribution to the customs work.

Thereafter, minutes of the PTFC meeting held on 12.01.2012 were discussed and accepted.

#### 1. 2. New Points raised in the PTFC meetings held on 09.02.2012:-

**2.1** Representatives of the BCHAA raised an issue that many times officers are asking for submission of

copies of Periodicals like LME, PLATT etc. at the time of assessment which delays the clearance. The Association suggested that department should subscribe to such periodicals so that LME, Platti etc. are available with the assessing officers.

The Chairman replied that generally copies of PLATT, LME etc., are not being asked for by the group officers. However, usage of improper wording in the querries raised by the assessing officers may have given an impression that these are being asked for. All assessing officers have been instructed to be precise and specific while raising querries and not to call for copies of PLATT/LME etc from the trade. The Custom House is in touch with DGOV for such data.

(ACTION: DC/SVB)

**2.2** The representatives of the BCHAA raised an issue that it takes minimum 2 to 4 days to complete amendment

procedure in import department. The Association requested to expedite the amendment procedure and to complete the

same in 1 to 2 days.

The Chairman stated that around 50 to 60 amendment applications per day are received in Import Noting Section. Minor amendments are cleared on the same day subject to production of proper documentation. Major amendments are also cleared on the same day or next day. The delay is caused due to non submission of all the relevant documents for amendments. However, Import Noting Section has been once again been advised to expedite the amendment procedure.

(ACTION: IMPORT NOTING)

**2.3** The Members of the Trade asked about the outcome on the reference sent to Board on the issue of FTA benefits in cases of High Seas Sales where the name of the Importer and the Invoice No. does not match with the FTA Certificate issued by the Exporting country. They reiterated that the Agreement benefit is meant for the goods imported and not to a specific Importer.

On this, Shri Satyajit Mohanty, Additional Commissioner of Customs, (Chief Commissioner's Office) informed the Chair that the Board, vide its letter F.No.21000/0/2012-OSD (ICD) dated 09.02.2012, has clarified that under the Free Trade Agreements, Certificate of Origin (CCO) is issued for a specific consignment under the relevant Rules of Origin agreed between the contracting parties, conferring originating status on the goods, thus if the goods are †originating' under the relevant rules and if the goods under import can be correlated to those covered under the Certificate of Origin, the â€æimporter†• under high sea sale may avail the benefit of †origin' under the relevant Free Trade Agreement subject to fulfillment of Foreign Trade Policy and any other laws in force. (Standing Order No.06/2012 dated 20.02.2012 has been issued to clarify this issue.)

(POINT CLOSED)

The meeting ended with thanks to the Chair.
