### **NEW POINTS**

#### **Point No. 1: Implementation of UQC:-**

**Request:** Some filed Officers are insisting for using of UQC for export shipment. In case of Export, documents are generally made as per export order received from the Buyer but documents are also made as per Quantity Code mentioned in the DES Licences. In case of Export under Drawback Scheme and if drawback is on quantity, there is field in the system to mention quantity as per requirement. It could be anything say KGS, SQMTR etc.

**Status:** The Unit Quantity Code has been stipulated in the Drawback schedule and no changes are required therein.

#### **Point No. 2: Open and examination of self-sealed containers which at the moment is more than 10%:-**

**Request:** More than 6 months have passed, opening and examination is being continued. We believe, time has come to re-visit the issue. Opening and examination is creating lot of hardship and financial burden.

**Status:** The instructions for open and examination are fully automated in the form of RMS on certain parameters and the same cannot be ignored/ overruled. Further, in pursuance to Board's Circular No.13/2018-Customs dated 30.05.2018, Mumbai Cus Zone-II has issued a Public Notice No.100/2018 dated 15.06.2018 wherein revised procedure for stuffing and sealing of reefer container has been prescribed.

#### **Point No. 3: Non availability of Line's Seal and it's procedure to get one:-**

**Request:** Line's seals are not available in the Parking Plazas. CBs are required to run to Line's offices or even to their empty yard on Sundays and holidays for seal which costs more

time. Travelling Costs etc. plus required to go through lot of formalities such as forwarding copy of Customs Notes, demand request by Exporter through their forwarders, payment etc.

**Status:** The matter is being pursued with the shipping lines to make arrangements for availability of the seals at the parking plazas and also at the reasonable rates.

**Point No. 4: Appraising officers at night and on Saturdays/Sundays/holidays:-**

**Request:** Purpose of 24 x 7 for factory stuffed containers get defeated if Appraising officers are not available. It will be appropriated if Appraising officers are available 24 x 7. Let Export order (LEO) facility should also be available 24 x 7.

**Status:** Currently, Officers from CEAC are posted in office till 2000 and Hrs as per Office order No. 01/2017-18 dated 26.03.2018. Also holidays posting of officers is done on a routine basis. Still if there is an instance of any requirement of officers post 2000 hrs, then the same may be brought to the notice and it will be looked into depending on the quantum of work.

**Point No. 5: Installation of Scanner:-**

**Request:** Today only CWC Distriparks has scanning facility. All Haz vehicles are required to move to Distriparks for scanning. Scanner is required at Parking Plazas to save cost and time.

**Status:** There is a proposal for new scanner to be installed at upcoming premium parking plaza being developed by JNPT.

**Point No. 6: Jurisdiction of Assistant/ Dy. Commissioners:-**

**Request:** Today, each Assistant Commissioner/Dy. Commissioner has responsibility to handle more than 5 CFS, Running between CFS consumes lot of time and delays release/LEO.

**Status:** Limited number of ACs/DCs. The issue may be looked into during the next rotation of Group-A Officers.

**Point No. 7: Cost of Line's Seal:-**

**Request:** Lines are using Bottle seals and MRP of seal is Aprox. Rs.22-25 but they charge Rs.500/- per seal.

**Status:** The matter will be discussed with CSLA.

**Point No. 8: Form 13:-**

**Request:** Shipping Line insist for fresh form 13 in case of open and Examination container. It consumes lot of time and results in delay of movement and some time results in missing of Vessel.

**Status:** The matter has already been discussed in the meeting held on 12.04.2018, chaired by the Commissioner of Customs (NS-Gen), JNCH. A copy of the same is enclosed herewith for your reference, please.

The above points could not be discussed as the members of Mumbaizone Customs Broker Association who had raised these points were not present in the meeting. The points will be taken up for discussion in next meeting.
