- 2. Deputy/Assistant Commissioners of Customs, in charge of Import/Export Docks under JNCH, also attended the meeting.
- 3. At the outset, the Chairman welcomed all the members. The agenda relating to Import Commissionerate were discussed first, and then following agenda of the Export/General commissionerates were deliberated upon.
- 4. All the old points of the previous PTFC meeting were closed. The discussion & decision in respect of Agenda points pertaining to NS-G, NS-II & NS IV Commissionerates are as under:-

5. NEW POINTS

Point No. 1: Re-print of shipping bills due to system issue:-

Request: Lots of shipping bills undergo reprint at Parking Plaza due to problem in EDI System. The export trade is facing difficulty at Parking Plaza since the procedure followed at Parking Plaza is different from procedure followed elsewhere. Officers at Parking Plaza are insisting for cancellation of LEO instead allowing reprint from AC/DC menu. It has been requested by the trade that in case of reprint due to EDI technical issue, reprint should be generated by AC/DC in charge of shift at Centralized Export Assessment Cell. Cancellation of LEO should not be insisted upon. The same facility should also be available on Sunday/Customs holidays.

Discussion: The Chairperson assured the trade members that the matter is under consideration and suitable action will be taken at the earliest.

(Attn: DC/Parking Plaza)

Point No. 2: Declaration for claiming higher rate of Drawback:-

Request: The trade has requested for specific process and time limit for settlement of Drawback claims where the export was already affected prior to the issuance of the Public Notice No. 101/2017. Further, the trade has requested for acceptance of single declaration as per Para 3 of Public Notice No. 101/2017, post the timeline of the said Public Notice. These claims should be settled immediately upon submitting the single declaration without asking the exporters to submit the supplementary claim.

Discussion: It was informed that self-declaration is to be submitted manually for processing of the disbursal of drawback. The trade members are not submitting self-declaration in this regard. Hence, it is requested to submit self-declaration to the Docks Officer while processing of the shipping bills. The Docks Officer will invariably feed the details of declaration in departmental comments of the EDI system. Further, it was informed that if there is any supplementary claim, then the same should be submitted as per Public Notice so as to enable processing of the supplementary claim at the earliest.

(Issue closed)

Point No. 3: Availability of AC/DC for Shipping bill assessment on Sunday/Holiday:-

Request:The trade has referred to Public Notice No. 64/2017 which states that Customs is working on 24 x 7 for exports. However, ACs/DCs are not available to finalize the assessment of shipping bills. It has been requested that AC/DC should also be available for completing the assessment

of shipping bills on holiday/Sunday. The charge of AO can be allotted to any Superintendent in Parking

Plaza for Sunday/holidays.

Discussion: The Chairperson informed that Public Notice No. 64/2017 dated 22.05.2017 states that

Customs is working on 24 x 7 with respect to only RMS facilitated and free shipping bills. However,

holiday posting of AC/DC will be issued for the assessment of shipping bills as requested by the trade

members. Facility Notice No. 122/2017 dated 28.09.2017 with respect to working of all assessing

Groups (including CEAC and RMS Facilitation Cell) and Docks at JNCH on 30.09.2017 has been

issued to for the processing and clearance of the import/export cargo considering the demand of trade

members.

Point No. 4: Implementing Electronic Sealing for containers by exporters under self-sealing

procedure:-

Request: It has been requested by the trade that a detailed SOP is required to be issued by

Public Notice sensitizing the trade and officers regarding the changes to be made as per Board's

Circular No. 26/2017, 36/2017 & 37/2017 regarding implementing Electronic Sealing for containers by

exporters under self-sealing procedure.

Discussion: The Chairperson assured that a detailed SOP will be issued once some operational issues

are sorted out. This office is taking the matter with Board as well in this regard. Public Notice No.

120/2017 dated 27.09.2017 has been issued with respect to implementation of Electronic Sealing for

containers by exporters under self-sealing procedure prescribed vide circular 37/2017-Customs dated

20.09.2017.

6. The Commissioner of Customs, NS – V informed that CBEC has released Trade Facilitation Action

Plan 2017 -2020 as per guidelines of WTO. In these guidelines, many changes have been mentioned

relating to ease of doing business. He explained important elements of said action plan. He further

added that more information will be given in every PTFC meetings.

(Issue closed)

7. The members of the meeting were informed that the next PTFC meeting shall be held on

26.10.2017at 11.30hrs at Conference Hall, 7th Floor, JNCH. The Chairperson requested all the
