- 2. Deputy/Assistant Commissioners of Customs, in charge of Import/Export Docks under JNCH, also attended the meeting.
- 3. At the outset, the Chairman welcomed all the members. The agenda relating to Import Commissionerate were discussed first, and then following agenda of the Export/General commissionerates were deliberated upon.
- 4. All the old points of the previous PTFC meeting were closed. The discussion & decision in respect of Agenda points pertaining to NS-G, NS-II & NS IV Commissionerates are as under:-

5. NEW POINTS

Point No. 1: Opening of RMS facilitated containers for inspection:-

Request: There have been instances when shipments facilitated under RMS, are directed to be opened for inspection. This procedure needs to be reviewed in the revised context.

Discussion: The Commissioner (General) informed that the issue will be considered and if found appropriate, the procedure prevailing since 2014 will be reintroduced for the cargo stuffed/sealed under physical supervision of C.E./GST authorities. As per instructions dated 20.05.2014 issued vide F.No.S/12-Gen-53/2013-14 AM(X).

<u>Point No. 2: Modification in Clause 4 of Circular No. 36/2017 issued by CBEC with respect to RFID:</u>

Request: Clause 4 of Circular No. 36/2017 issued by CBEC makes it obligatory on the part of exporters to furnish various information under RFID process and two of the information required are shipping bill no and shipping bill date. These data will be only available only after the containers reach Mumbai and not at the time of affixing the seal. Hence, it is requested to modify the said circular accordingly so that the documents are not rejected for deficiency.

Discussion: It was informed that exporters are expected to file shipping bill earlier so as to feed the information as per circular. It was also clarified that the requisite details are to be fed into the system anytime before the scanning of E-Seal by the customs at the time of examination.

Point No. 3: Permission to use bottle seals for some time with respect to a few ISO where the LID are not large enough to match the required diameter of RFID seals:- in such cases we may be permitted to continue use bottle seals for some time till modifications in the lids are done.

Request: Permission to use bottle seals for some time with respect to a few ISO where the LID are not large enough to match the required diameter of RFID seals. In such cases, the trade requested to permit to continue use bottle seals for some time till modifications in the lids are done.

Discussion: The Chairman assured that the matter would be considered and the decision will be conveyed.

<u>Point No. 4: RFID containers once LEO is issued and if the container is shutout, process that is needed to be followed has to be prescribed.</u>

Request: RFID containers once LEO is issued and if the container is shutout process that is needed to be followed has to be prescribed.

Discussion: The Chairman informed that the issue has already been taken care of in the public notice no.73/2017 and if any specific instance is brought to the notice, the requisite orders/instructions will be issued.

Point No. 5: Hazardous cargo in ISO tanks as sampling in the customs area pursuant to an open order was not practical we were advised to dispatch the same under excise supervision, in the current context under RFID Sealing it will be essential to have the process redefined.

Request: Sampling of hazardous cargo in ISO tanks in the customs area pursuant to an Open and Examination order is not practical and the exporters were advised to dispatch the same under supervision of jurisdictional Customs (Preventive)/GST Officers, in the current context under RFID Sealing, it will be essential to have the process redefined.

Discussion: As per Point 1 above. [Attn. DC/Parking Plaza]

Point No. 6: Requirement of Form E -13 for export cargo at the time of entry of goods at Parking Plaza and for generation of LEO.

Request: Endeavour of creation of Parking Plaza was to facilitate smooth processing of export cargo. The Officers should not insist on Form E-13 for export cargo at the time of entry of goods at Parking Plaza and for generation of LEO (Reference PN No. 73/2017).

Discussion:- It was informed that Form – 13 is being insisted upon so as to ensure that there should not be any case of vessel shut out and to ease out traffic situation caused by early arrival of containers. The Commissioner (General) also assured to discuss the issue with stake holders in a separate meeting to be held shortly. [Attn. DC/Parking Plaza]

Point No. 7: Facilitation of RMS for export cargo needs to be increased considerably.

Request: Facilitation of RMS for export cargo needs to be increased considerably.

Discussion: Facilitation of RMS for export cargo is being dealt by Risk Management Division and

it is increased as per decision taken by RMD.

Point No. 8: Procedure for examination/opening of factory stuffed/self sealed containers in case

of instructions in EDI system.

Request:- There is requirement of laying down procedure for examination/opening of factory

stuffed/self sealed containers in case of instructions in EDI system.

Discussion:- In case open and examine instructions are given in EDI system for the factory

stuffed/self sealed containers, the same is opened and examined as per Public Notice 3/2017 and in

case of Hazardous Cargo the procedure prescribed in PN 43/2017 is being followed. The Chairman

informed that the EDI/RMS instructions will be followed for examination of such containers as the

instructions are given as per risk basis analysis by the Risk Management Division. After hearing the

grievances from the Trade in this regard, the Commissioner (General) informed that the issue will be

considered and if found appropriate, the procedure prevailing prior to 2014 will be reintroduced, in

respect of factory stuffed containers under physical supervision.

Point No. 9: Concerns with Electronic Sealing of Containers in terms of Public Notice No.

26/2017 with regard to frozen sea food :-

Request: The trade members informed that examination of cargo would take place at port in

ambient conditions which could mean high temperature and dusty dirty conditions. The temperature

during summer can exceed 45 degrees Celsius. As one opens the container hot air rushes in. The air

would cause condensation affecting the efficiency of the refrigeration unit. In all probability the

container would arrive at destination 5 to 10 degrees higher than the stipulated minimum

temperature, and this would result in rejection by overseas health authorities. There is also

possibility of wind-blown dust as well as insects entering the container. Trade has requested to

review procedures and exempt frozen fish products from the examination at port or to continue with

old system of sealing containers under supervisions of the officers or any other procedure may be

followed.

Discussion:- As per Point No.1.
