3. Shri Sushil Chandra, Addl. Commissioner of Customs, JNCH started the discussion on the agenda points of the meeting related to the import.

4. कार्यविन्दु / AGENDA POINTS:

बी.सी.बी.ए. के द्वारा उठाया गया कार्यविन्दु/Agenda Point raised by BCBA

कार्यविन्दु संख्या 01/Agenda Point 01: All terminals insisting email with documents for obtaining unique DPD Code to DPD Importers: This is in reference to enhancing Direct Port Delivery vide PN No 71/2021 and 125/2018 where DPD Importers are required to register at JNPCT and only JNPCT will allot unique code to these DPD importers. They have brought to the notice of department that all terminals are insisting to send a separate email along with documents for obtaining unique DPD Code to DPD importers. They requested for intervention in the case.

प्रतिक्रिया/Response: JNPT has already provided access of their Registration portal to all Terminals to view details of registered importers and download their documents as per PN 71/2021. Moreover, daily mail is also being sent from JNPT with details of Registration done on previous day to all partner Terminals, so that they can also suo-moto register such DPD importer (on the basis of KYC already conducted by JNPCT) and open the PD account for them. However, Terminals (NSICT/NSIGT/APMT) have intimated that they are in the process of system integration with JNPT hence they are requesting some documents such as Bank account details, GST details, cancelled Cheque etc. for maintaining the PD account. Further, the Terminals are once again directed to follow the PN & system up-gradation /integration may be done as early as possible.

कार्यविन्दु संख्या 02/Agenda Point 02: EIR Copies to be accepted as Weighment Proof: They have submitted that examination orders are being given for weighment of goods. We request dept to accept EIR copies issued by CFS as weighment proof, as this will save time and cost.

प्रतिक्रिया/Response: Issue is being examined in view of the existing practices and safety and security of the cargo.

कार्यविन्दु संख्या 03/Agenda Point 03: Problems faced in CO verification of Vietnam as OOC is not being given through system: It has been brought to the notice of the Association that members have to approach EDI AC for release of consignments. This procedure is time consuming.

प्रतिक्रिया/Response: Any Bill of Entry comes to Deputy Commissioner of Customs, EDI, JNCH only for revocation if suspension of Out of Charge is imposed by RMCC/Any other agency. It is a policy issue. Suitable Standing Order No. 40/2020 vide F.No. EDI/Misc-154/2017/JNCH

dt.02.11.2020 has been issued in this regard. Further, trade is advised to submit some B/E to examine the issue.

**कार्यबिन्दु संख्या 01/Agenda Point 01: Expediting the decision of Hold containers withheld by Various Investigating agencies** – CFSAI had submitted fresh list of **1678** containers (**2227 TEUS**) vide email dated 11<sup>th</sup> Aug 2021 that are put on hold by various investigating agencies CIU, Court Case, Custom Hold, Docks, DRI, MPIU, NSPU, R&I Police & SIIB. The List is summarized as below for your easy reference:

They have requested to take this up with the concerned agencies for expeditious disposal & release of such containers which will help Member CFSs in utilizing the space for other Import containers free from hold.

**प्रतिक्रिया/Response:**

(i) An office Order has already been issued vide F.No. SG/Misc-338/2019-20/SIIB(I) JNCH dated 19.11.2020 regarding the consignments/containers which are put on hold by SIIB(I) on the basis of intelligence received or intelligence developed. In the said order, instructions as under are issued to officers.

(a) That such hold consignments/containers are to be examined by SIIB (I) officers under panchnama expeditiously.

(b) that in the cases where investigation is likely to take some time, it may lead to imposition of ground rent charges by CFS and container demurrage charges by shipping line. Therefore, all staff has been sensitized to give importer an option availing facility of Section 49 of the Customs Act, 1962 without waiting for importer's request letter for such permission.

(ii) Further, it is informed that a dedicated team of SIIB (I) officers have been formed for the expeditious disposal of the 'long standing containers' and also a letter has been written to all CFS for obtaining requisite data regarding the containers. Members of the team have been directed to obtain the current status of the case pertaining to the containers, thereby, NOC may be granted for disposal of goods stuffed in the containers.

**कार्यबिन्दु संख्या 02/Agenda Point 02:** Longstanding un-cleared/unclaimed goods pending for Adjudication at Appraising Groups- CFSAI had submitted fresh list of 668 containers that are pending for Adjudication vide email dated 4<sup>th</sup> Aug 2021. They have requested to give required

directions to officers at various Groups in expediting the adjudication process and speedy disposal of longstanding cargo.
