Such SQL report will be generated invariably every fortnight by ADC / JC EDI for all the Commissionerates.
- 4 As BE assessment activity is undertaken in the Appraising Halls, any such prior approval obtained must be informed immediately to the Control Room officer by the Additional / Joint Commissioner concerned; and record of this permission shall be maintained in the Control Room register. The Office Order vide F.No. S/43-(G)-305/2021-22/PSO/JNCH dated 23.06.2021 (copy attached) shall also be followed.
- During10 PM to 8 AM, the Control Room officer and staff will monitor the entry and exit of 5. officers/staff into the Custom House and especially so the access to the Appraising Halls or any other place where assessing officer have their office.
- The Control Room officer in day shift shall report any activity between 10 PM to 8 AM that has come 6. to notice in the night shift to the Commissioner NS-General daily in writing including a "Nil" report.

OFFICE ORDER

The control room officer is hereby instructed to ensure proper entry and exit of officers/visitors into the JNCH Custom House. The same has to be strictly regulated between 10pm -8am. In this regard, the following specific charter of duties is prescribed for the control room officers:
