Vide Notification No. 12/2016 dated 23.12.2016, Container Freight Station M/s International Cargo Terminal Pvt. Ltd., located at village- Koproli Tal: Uran, Dist: Raigad, Maharashtra - 410 206 had been notified as "Customs Area" for an area admeasuring 66,900 SQM.

An additional area of 26,070 SQM located adjacent to the above CCSP was further declared as Customs Area vide notification no 06/2019 dated 12.06.2019.

M/s International Cargo Terminal Pvt. Ltd. has requested to expand their Customs area by adding land parcel admeasuring 1355 SQM in Survey No. 101/1/B/2 adjoining the existing premises of CCSP M/s International Cargo Terminal Pvt. Ltd.

Now, in the exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, B. Sumidaa Devi, Commissioner of Customs, Nhava Sheva-General, Jawaharlal Nehru Custom House, Mumbai Customs Zone-II, hereby specify the following area as Customs area measuring 1355 SQM as a place for unloading of imported goods and for loading of export goods, subject to the strict observance of the provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs, Nhava Sheva-General, Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House from time to time.
