**CFS Notification No.09/2019**

Vide Notification No. 01/2016 dated 22.03.2016, Container Freight Station M/s JWR Logistics Private Limited, located at 15-45, National Highway 4B, Panvel- JNPT Highway, Village Padeghar, Taluka: Panvel, Maharashtra - 410 206 had been notified as "Customs Area" for an area admeasuring 1,13,889 SQM.

M/s JWR Logistics Private Limited has requested to expand their CFS area by adding two land parcels admeasuring 6500 SQM on Survey No. 15 A/1 and another admeasuring 12,951 SQM on Survey No. 45 C(Part) which is adjoining the existing premises of CFS M/s JWR Logistics Private Limited.

Now, in the exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, Utkaarsh R Tiwaari, Commissioner of Customs, Nhava Sheva-General, Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House, hereby notify Container Freight Station situated at 15-45, National Highway 4B, Panvel- JNPT Highway, Village Padeghar, Taluka: Panvel, Maharashtra - 410 206 of M/s JWR Logistics Private Limited as a place for unloading of imported goods and for loading of export goods, subject to the strict observance of the Provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs, Nhava Sheva-General, Mumbai Customs, Zone-II, Jawaharlal Nehru Custom House from time to time.

Further, under Section 8(b) of the Customs Act, 1962, I, Utkaarsh R Tiwaari, Commissioner of Customs, Nhava Sheva-General, JNCH hereby specify the limits of the Customs Area comprising the above Container Freight Station situated at 15-
