The area admeasuring 8 acres of Container Freight Station of M/s. JWC Logistics Park Pvt. Ltd. located at Plot No. 69/91, Village Palaspe, Bombay Goa Road, Panvel, Dist. Raigad, Maharashtra-400707 was declared as Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 17/2006 dated 19.05.2006. Further, an additional area admeasuring 3.5 acres of the said CFS M/s. JWC Logistics Park Pvt. Ltd. located at Plot No. 69/91, Village Palaspe, Panvel, Raigad was declared as Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 13/2010 dated 21.04.2010.

2. M/s. JWC Logistics Park Pvt. Ltd. vide their letters dated 26.03.2018 and 29.03.2018 have requested to notify further area of 3.237 acres of land covering Plot Nos. 72/4B/6/5A and 72/4A of the said Container Freight Station.

3. Now, in exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, Utkaarsh R. Tiwaari, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava Sheva, further notify an additional area of land admeasuring 3.237 acres of the said Container Freight Station of M/s. JWC Logistics Park Pvt. Ltd. located at Plot Nos. 72/4B/6/5A and 72/4A, Village-Palasppe, Taluka-Panvel, Distt. -Raigad., Maharashtra as a place for unloading of imported goods and for loading of export goods subject to the strict observance of the Provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs (NS-General), Jawaharlal Nehru Customs House, from time to time. The additional area shall become part of the original CFS of M/s. JWC Logistics Park Pvt. Ltd. having a single gate. Therefore, the total area of 15.237 acres has become the Customs Area for the purpose of storage, stuffing and de-stuffing of Export/Import cargo (Bonded as well as Home consumption).

4. Further, under Section 8(b) of the Customs Act, 1962, I, Utkaarsh R. Tiwaari, Commissioner of Customs (General) hereby specify the limits of the

Customs Area comprising the above Container Freight Station located at Village-Palasppe, Taluka-Panvel, Distt. -Raigad, Maharashtra admeasuring 15.237 acres as under:

EAST : Land of village Palasppe, Panvel

WEST : NH No. 17 i.e. Bombay-Goa Road

NORTH : Land of village Palasppe, Panvel

SOUTH : Land of Ebal Kaji's 72/3B & 89/6A and Land of M/s. Oceangate Container Terminals Pvt. Ltd.'s plot No. 75
