Subject:

Guidance to CFS/ICD on the waiver of penal charges on the imported goods/containers lying at CFSs/ICDs beyond the normal free period during the imposition of lockdown to contain Covid-19 pandemic in our country

In continuation of contents brought to your notice under this Office letter No.S/5-Gen/45/2019-20/CCSP Cell/JNCH dated 27.03.2020 and the letters of even number dated 09.04.2020 and 23.04.2020, it is conveyed that -

- (a) the lockdown measures to contain the pandemic result in logistics chain of businesses being most adversely impacted. This includes activities of stakeholders such as importers, their representatives, transporters, labour, etc who are concerned with dealing with the clearance of cargo from the Customs facilities be they be called Ports, CFSs, ICDs. The result is that importers are not able to clear the import consignments for the reasons that are beyond their control. In these circumstances, the consignments or segments thereof - are forced to temporarily remain longer in the place where they are held or are temporarily retarded from being cleared as would have been normally expected.
- (b) the above conditions are of goods detained by force of circumstances created by law, with difference being that instead of individual goods being released by individual orders, there is the generality that the time over the normal free period with respect to individual consignments being cleared dovetails logistics chains of businesses adjustments to these measures. The above referred type of adjustments leads to retarding the rate of above said retardation and eventually overcoming it. This reflects since from 23.03.2020, CFSs have collectively assisted such adjustments to take effect, and thereby participated in gating-out daily progressively higher numbers of import TEUs, with last two days average being over 3000 TEUs per day.
- (c) the result of the present lockdown situation presents the specific occasion for you to sensitively view the above situation in perspective and as akin to when goods detained per HCCAR, 2009. As the long-term and valued stakeholders in the lay-out and business plan of the JN Ports wherein you also function as Customs Docks, it is the understanding that you are, and would be, acting reasonably in the matter of devising, deciding and issuing the waivers in terms of Govt advisories.

 Present guidance is issued as this Administration continues to receive fairly large number of email grievances on the issue from importers.
