## **CORRIGENDUM**

Subject: Corrigendum to Order-in-Original No. 153/2025-26/COMMR/NS-V/CAC/JNCH dated 04.08.2025 issued by the Commissioner of Customs, NS-V, JNCH in the case of M/s. K. V. Impex – reg.

Attention is invited to the Order-in-Original No. 153/2025-26/COMMR/NS-V/CAC/ JNCH dated 04.08.2025 issued by the Commissioner of Customs, NS-V, JNCH, in the case of M/s. K. V. Impex.

1. In para 5(a) at Page No. 46 of the Order-in-Original No. 153/2025-26/COMMR/NS-V/CAC/JNCH dated 04.08.2025, the words:

"I order that the subject imported goods used in manufacturing of toys should be reclassified under Customs Tariff Heading 9503."

#### May be read as

"I order to re-classify the subject imported goods used in manufacturing of toys under Customs Tariff Heading 9503."

2. In para 5(b) at Page No. 46 of the Order-in-Original No. 153/2025-26/COMMR/NS-V/CAC/JNCH dated 04.08.2025, the words:

"I order that an amount of Rs. 71,88,325/- (Rupees Seventy One Lakh Eighty Eight Thousand Three Hundred Twenty Five Only) as detailed in Table-III of the subject SCN, should be demanded and recovered from M/s K.V. Impex under Section 28(4) of the Customs Act, 1962."

#### May be read as

"I confirm the demand of Rs. 71,88,325/- (Rupees Seventy One Lakh Eighty Eight Thousand Three Hundred Twenty Five Only) as detailed in Table-III of the subject SCN, and order to recover the same from M/s K.V. Impex under Section 28(4) of the Customs Act, 1962."

3. In para 5(c) at Page No. 46 of the Order-in-Original No. 153/2025-26/COMMR/NS-V/CAC/JNCH dated 04.08.2025, the words:

"I order that interest should be demanded and recovered from M/s K.V. Impex, on the amount of Rs. 71,88,325/- (Rupees Seventy One Lakh Eighty Eight Thousand Three

Hundred Twenty Five Only) demanded at (b) above, under Section 28AA of the Customs Act, 1962."

## May be read as

"I confirm the demand of interest from M/s K.V. Impex, on the amount of Rs. 71,88,325/-(Rupees Seventy One Lakh Eighty Eight Thousand Three Hundred Twenty Five Only) confirmed at (b) above, and order to recover the same under Section 28AA of the Customs Act, 1962."

4. In para 5(d) at Page No. 46 of the Order-in-Original No. 153/2025-26/COMMR/NS-V/CAC/JNCH dated 04.08.2025, the words:

"I order that the goods valued at Rs. 1,21,17,401/- (Rupees One Crore Twenty One Lakh Seventeen Thousand Four Hundred and One Only) imported as detailed in Table-III of the SCN, should be held liable for confiscation under Section 111(m) of the Customs Act, 1962.

However, since the goods are not available, I impose a redemption fine of Rs. 10,00,000/- (Rupees Ten Lakh Only) on M/s K.V. Impex in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

#### May be read as

"I order to confiscate the goods having assessable value of Rs. 1,21,17,401/- (Rupees One Crore Twenty One Lakh Seventeen Thousand Four Hundred and One Only) as detailed in Table-III of the SCN, under Section 111(m) of the Customs Act, 1962.

I also impose a redemption fine of Rs. 10,00,000/- (Rupees Ten Lakh Only) on M/s K.V. Impex in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

5. Rest of the contents of the aforesaid Order-in-Original remains unchanged.
