CORRIGENDUM

Subject: Corrigendum to Order-in-Original No. 96/2025-26/Commr./NS-V/CAC/JNCH dated 23.06.2025 issued by the Commissioner of Customs, NS-V, JNCH in the case of M/s. Envision Wind Power Technologies India Private Limited – reg.

Attention is invited to abovementioned Order–in-Original No. 96/2025-26/Commr./NS-V/CAC/JNCH issued by the Commissioner of Customs, NS-V, JNCH.

1. In para 5(i) at Page No. 31 of the Order-in-Original No. 96/2025-26/Commr./NS-V/CAC/JNCH dated 23.06.2025, the words:

"I order that differential duty of Rs.66,26,219/- (Rupees Sixty Six Lakh Twenty Six Thousand Two Hundred Nineteen Only) on account of Anti-Dumping Duty of Rs.63,10,685/- (Rupees Sixty Three Lakh Ten Thousand Six Hundred Eighty Five Only) as applicable vide Notification No. 42/2017-Customs (ADD) dated 30.08.2017 on the aforesaid goods viz. 3 item entries (Sl. No. 6, 15 & 21) of Annexure-'A' to the subject SCN and applicable IGST of Rs.3,15,534/-, should be recovered from M/s. Envision Wind Power Technologies India Pvt. Ltd. under Section 28(4) of the Customs Act, 1962, along with applicable interest under Section 28AA of the Customs Act, 1962."

May be read as

"I confirm the demand of Rs.66,26,219/- (Rupees Sixty Six Lakh Twenty Six Thousand Two Hundred Nineteen Only) on account of Anti-Dumping Duty of Rs.63,10,685/- (Rupees Sixty Three Lakh Ten Thousand Six Hundred Eighty Five Only) as applicable vide Notification No. 42/2017-Customs (ADD) dated 30.08.2017 on the aforesaid goods viz. 3 item entries (Sl. No. 6, 15 & 21) of Annexure-'A' to the subject SCN and applicable IGST of Rs.3,15,534/-, and order to recover the same from M/s. Envision Wind Power Technologies India Pvt. Ltd under Section 28(4) of the Customs Act, 1962 along with applicable interest under Section 28AA of the Customs Act, 1962."

3. In para 5(ii) at Page No. 31 of the Order-in-Original No. 96/2025-26/Commr./NS-V/CAC/JNCH dated 23.06.2025, the words:

"I order that the goods pertaining to aforesaid 3 item entries (Sl. No. 6, 15 & 21) of Annexure-'A' to the subject SCN, valued at Rs.1,65,74,267/- (Rupees One Crore Sixty Five Lakh Seventy Four Thousand Two Hundred Sixty Seven Only) should be held liable for confiscation under Section 111(m) of the Customs Act, 1962.

However, since the goods are not available, I impose a redemption fine of Rs.15,00,000/-(Rupees Fifteen Lakh Only) on M/s. Envision Wind Power Technologies India Pvt. Ltd. in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

May be read as

"I order to confiscate the goods pertaining to aforesaid 3 item entries (Sl. No. 6, 15 & 21) of Annexure-'A' to the subject SCN, valued at Rs.1,65,74,267/- (Rupees One Crore Sixty Five Lakh Seventy Four Thousand Two Hundred Sixty Seven Only), under Section 111(m) of the Customs Act, 1962.

I also impose a redemption fine of Rs.15,00,000/- (Rupees Fifteen Lakh Only) on M/s. Envision Wind Power Technologies India Pvt. Ltd. in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

5. Rest of the contents of the aforesaid Order-in-Original remains unchanged.
