PUBLIC NOTICE No. 75 / 2008

Sub : Commencement of Third Shift working (10 P.M. to 6 A.M) of Customs at Nhava Sheva Port reg.

Attention of all importers, exporters, CHAs and general trade is invited to the following Public Notices/Facility Notices:-

- i) [Public Notice Nos. 03/2008](#) dated 02.01.2008; [24/2008](#), dated 12.03.2008 and [58/2008](#) dated 04.08.2008 all relating to second shift working (up to 10 P.M.) for examination of imported goods at specified CFSs under the jurisdiction of JNCH.
- ii) [Public Notice No. 51/2008](#) dated 01.07.2008 regarding second shift working processing of documents and granting of LEO for factory stuff/self sealed export cargo; and
- iii) [Facility Notice No. 11/2008](#) dated 23.01.2008 regarding Holiday Posting of officers.

2. Considering the increasing volume of business at Nhava Sheva Port and to improve the productivity of the existing infrastructure, and taking into account the needs of the trade, it has been decided to introduce Third Shift Working (10 P.M. to 6 A. M.) on trial basis at JNCH as a further trade facilitation measure.

2.1 One set of officers comprising one Asstt/Dy. Commissioner of Customs, one AO/Supdt., one PO/EO and one Sepoy/Hawaldar shall be posted on 3rd shift (10 P.M. to 6 A. M) on six days week basis (except 2nd Saturday and holidays). They will be **stationed at TILP (All Cargo) CFS** during the 3rd Shift.

2.2 The following work shall be attended to in the third shift:-

i) To give Out of Charge on RMS facilitated Bills of Entry for the imported goods lying in the following CFS:-

- a) Trans India Logistic Park (All Cargo);
- b) Speedy Multimode Ltd; and
- c) C.W.C.L. (Continental).

ii) To grant LEO in respect of the factory stuffed/self seal export cargo covered under the Shipping Bills already assessed in I or II shift at any CFS;

- iii) Work relating to import noting / SMTP;
- iv) Registration of factory stuffed and self sealed containers;
- v) Any other emergency work with the approval of the Commissioner.

3. This issues with the concurrence of Commissioner of Customs (Exports), JNCH. Any difficulty noticed in the implementation of this Public Notice may be brought to the notice of the undersigned.

4. This Public Notice comes into force w.e.f. 01.11.2008.
