Subject : Data quality of information furnished by importers and exporters regarding.

Jawaharlal Nehru Custom House had issued a [Public Notice No.124/2010](#) dated 07.12.2010 emphasizing the need for better data quality. Interactive sessions were conducted in Conference Hall of JNCH in April, 2010 for educating the Custom House Agents and members of the trade to appraise them the benefits of good data quality and legal requirements thereof.

2. Subsequent to that, improvement in data quality has been noticed but there is still scope and need for further improvement. Accordingly, this Customs House and BCHAA has planned to arrange jointly more numbers of interactive sessions so that the message of benefit of good data quality is percolated to all stakeholders.
