Sub:- Partial Modification to the Public Notice No.127/2016 JNCH dated 16.09.2016 - Reduction in no. of documents required to be submitted for Registration with Port authorities - Reg.

Attention of all importers, exporters, Customs Brokers, and members of trade is invited to the Public Notice No.127/2016 JNCH dated 16.09.2016 wherein at para 10.1(i) a list of documents was required to be submitted along with the duly filled in registration form to get registration with the port terminals.

- 2. To ensure faster registration and as a step towards 'Ease of Doing Business', documents mentioned at para 10.1 (i) of the Public Notice No.127/2016 JNCH dated 16.09.2016 has been reduced and Para 10.1 (i) of the above mentioned Public Notice stands amended and the same may be read as following:
- "10.1 (i) The importer who intends to avail DPD facility is required to submit duly filled in registration form along with following documents to get them registered with the port terminals:
 - a) A request letter mentioning the Sr. No. in the list of Public Notice No.161/2016 JNCH dated 28.11.2016 or Public Notice No.180/2016 JNCH dated 19.12.2016 or self-attested copy of permission letter issued by JNCH, Nhava Sheva for DPD facility.
 - b) Self-attested copies of PAN card.
 - c) Letter of authorization of Custom Broker for carrying out clearance of containers.
 - d) List of authorized signatories of the company on the letter head.
 - e) Name of preferred CFS in case, container of DPD Client is not RMS facilitated.
- 3. Difficulties, if any, faced in implementation of these instructions may be brought to the notice of the Commissioner of Customs NS-III.
