Sub: Examination of Export goods at Export Docks in two Shifts.

Attention of all Exporters, Customs Brokers and other stakeholders is invited on the various instructions issued on registration and examination of goods in Export Docks.

- Now as a measure of further trade facilitation and to promote the "Ease of Doing Business", it has been decided to begin, the Examination of Export goods at 2. Export Docks in two Shifts at JWR CFS w.e.f. 01/03/2023.
- To operationalize this facility, officers will be now available from 9 AM to 9 PM in 3. the JWR Container Freight Station (CFS). The Officers posted in the JWR CFS from 9 AM to 9 PM will attend to regular customs clearances of Cargo covered under all types of Shipping Bills in 2 shifts.

Shift 1	9 AM	5 PM
Shift 2	1 PM	9 PM

- The first shift of officer will be started at 9 AM to 5 PM and the second shift of officers will start from 1 PM to 9 PM.
- In view of the above, DC/ AC Export Docks have to ensure that:
 - i. All shipping bills are allowed for registration from 9 AM to 8 PM.
 - ii. Suitable number of officers are available in each shift.
