3. To operationalize this facility, officers will now be available from 9 AM to 9 PM in the CEAC, CPP. The Officers posted in the CEAC, CPP from 9 AM to 9 PM will attend to regular assessment of all types of Shipping Bills in 2 shifts.

Shift 1	9 AM to 5 PM
Shift 2	1 PM to 9 PM

4. The first shift of officers will start from 9 AM to 5 PM and the second shift of officers will start from 1 PM to 9 PM. The trade is requested to make full use of this facility.

5. DC/AC (CEAC) has to ensure that suitable number of officers are available in each shift.
