Subject: Mandatory Additional Qualifiers in Import/Export Declarations in respect of

Certain Products-reg.

Attention of all Importers/Exporters, Custom Brokers, CFSs, Custodians, General Trade, Partner Government Agencies (PGAs), all other stakeholders and all taxpayers is invited to CBIC Circular No. 15/2023-Customs dated 07.06.2023 and Circular No. 23/2023-Customs dated 30.09.2023 wherein it has been decided to make Additional Qualifiers mandatory in Import Declarations in respect of Certain Products, in consultation with Department of Chemicals and Petrochemicals, Ministry of AYUSH and the Directorate General of Foreign Trade (DGFT).

This measure would lead to effective avoidance of queries, enhancing efficiency in 2. assessment and facilitation, avoid making references to technical agencies and addressing basic causes for delays in clearance, apart from better aiding policy-making.

#### Additional Qualifiers in respect of Imports:

- In terms of the Bill of Entry (Electronic Integrated Declaration and Paperless Processing) Regulations, 2018, it has been decided to enable the following additional qualifiers as mandatory from the beginning, that is, the time of filing import declarations itself:
- For the commodities imported under Chapters 28, 29, 32, heading 3808 and Chapter 4.1 39, , it has been decided to seek additional details mandatorily at the time of filing import declarations as follows:

#### **Chemical Category:** a)

- Bulk and Basic Chemicals: (1)
- Formulations and Mixtures, or  $(\Pi)$

### b. In case of above chemical categories:

Chemical Category	Additional Details required
Bulk and Basic Chemicals	CAS number and IUPAC name is mandatory
Formulations and Mixtures	CAS number and IUPAC name of Main/ Active ingredient
	(atleast one) is mandatory
Proprietary component,	CAS number or IUPAC name of Main/ Active ingredient
R&D or Others	(atleast one) is mandatory

4.2 In case of non-availability of information for even one ingredient with the importer for the reason that information is not shared by the supplier due to confidentiality, a self-undertaking is to be provided in the Bill of Entry as follows:

#### Declaration on non-availability of CAS & IUPAC details

"I certify that the information related to IUPAC &CAS number is not in my possession as the same is not provided by my supplier due to confidentiality."

- 4.3 The details of constituents declared in the Bill of Entry will be printed as masked fields in the Bill of Entry.
- 4.4 These additional qualifiers shall be mandatory for imports under the said chapters for all bills of entry filed on or after 15.10.2023, in the manner mentioned in the Annexure-A (attached) to this Public Notice. These fields shall be in addition to the existing declaration being made by importers.
- 5. System has enabled to capture an alpha numeric code identifier for commodities imported under Chapters 28, 29, 32, heading 3808 and chapter 39 of the Customs Tariff Act, 1975, at the item level in the Bill of Entry filed in the EDI System w.e.f. 15th October 2023. Accordingly, for identifying the Chemical category, the importers or Customs Brokers are mandatorily required to declare one of the chemical categories for those identified CTHs under the Single Window tables (SBE\_ITEM\_SW\_INFO\_TYPE and SBE\_ITEM\_SW\_CONST) of the Bill of Entry at item level with following details:

6. The above additional qualifier details can be viewed at the time of assessment under view\_BE tab. During assessment, if the officer changes the CTH, then an option has been provided for officer to add these additional qualifiers. In case of non-availability of information for even one ingredient with the importer for the reason that information is not shared by the supplier due to confidentiality, a self-undertaking is to be provided in the Bill of Entry by the importer under Statement Code PC002 as follows:

Kind reference is invited to the Board's Circular 15/2023-Customs dated 07.06.2023, Circular 18/2023- Customs dated 30.06.2023 and Circular 23/2023-Customs dated 30.09.2023 on the above subject.

2. To implement para 4 of the above circulars, the system has enabled to capture an alpha numeric code identifier for commodities imported under Chapters 28, 29, 32, heading 3808 and chapter 39 of the Customs Tariff Act, 1975, at the item level in the Bill of Entry filed in the EDI System w.e.f. 15<sup>th</sup> October 2023. Accordingly, for identifying the Chemical category, the importers or Customs Brokers are mandatorily required to declare one of the chemical categories for those identified CTHs under the Single Window tables (SBE\_ITEM\_SW\_INFO\_TYPE and SBE\_ITEM\_SW\_CONST) of the Bill of Entry at item level with following details:
