Attention of all exporters/importers, Customs Brokers, CFSs, Custodians, General Trade, Partner Government Agencies (PGA) under the jurisdiction of Mumbai Customs Zone-II, JNCH, all other stakeholders and all the tax payers is invited to ICES Advisory No: 12/2024 issued on 22.07.2024 regarding updating Union Budget 2024-25 in the ICES system. As per the advisory, the filing of Bills of Entry was not available in ICEGATE from 11:00 AM on 23.07.2024 till the completion of updating of all changes in ICES.

- **2.** In this regard, it is observed that some importers could not file the Bill of Entry due to this non-availability of the system.
- **3.** In view of the above, "late Fee" imposable in terms of Bills of Entry (Forms) amendment Regulations, 2017 vide Notification No. 27/2017-Customs (N.T.) dated 31.03.2017 will be waived off in respect of Bills of Entry, filed belatedly, which pertains to IGMs filed from 11:00 AM on 23.07.2024 till 04:00 PM on 24.07.2024. The necessary compliance is to be done by DC/AC of the concerned Groups.
- **4.** This Public Notice should be considered as Standing Order for the concerned Officers and Staff of this Custom House.
