Attention of all the Importers, Exporters, General Trade, Other stakeholders, and Officers of Nhava Sheva is invited to Directorate General of Systems and Data Management Advisory No: 08/2025 dated 31.01.2025.

2. For trade facilitation, necessary changes have been made in the System for importers to request for **provisional assessment** at the time of **filing bill of entry**, so that there is **no requirement to recall RMS facilitated bill of entry**.

3. A new field **“Prov”** has been provided in the system to request for provisional assessment of bill of entry. The importers/CHA while filing bill of entry has to mark this field as **“Y”** to request for provisional assessment of bill of entry at the time of **filing through service center**. The same facility will be available on ICEGATE website in due course. Copy of screenshots of the above flag is attached as **Annexure to this Public Notice**.
